DRAFT FARE CHANGE PROPOSAL AND TIMELINE
PUBLIC COMMENT REPORT
 September 1, 2018

Summary

The following report contains the public comments received by VCTC regarding the *Draft Fare Change Proposal and Timeline*, during the **period of August 1, 2018 through August 29, 2018**.

Background:

As presented at the July 2018 Commission meeting, the **Draft Fare Change Proposal and Timeline** (Proposal) modifies the current VCTC fare structure over two “phases.” The first phase of changes take effect January 2019 and the second phase of changes take effect in one year, January 2020.

The following charts reflect the Proposal. As noted, a new fare product, a short-term “5-Day Pass” (good for unlimited rides over 5 days) was proposed as part of the first phase of changes.

Public Comment Received

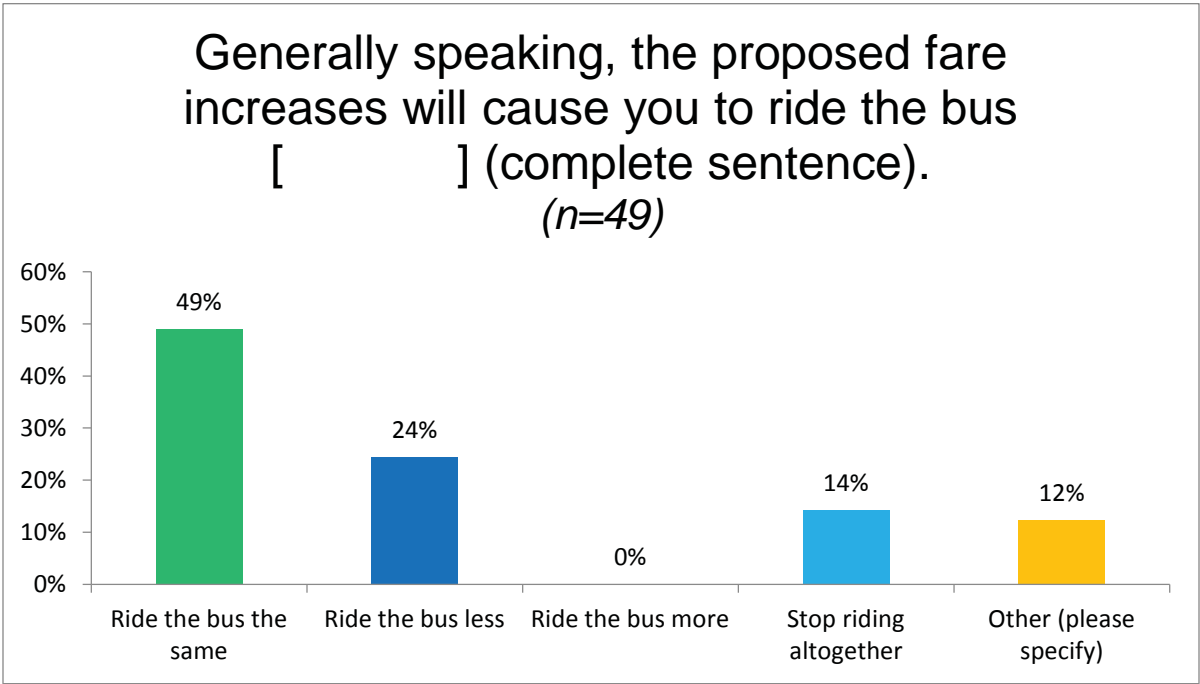
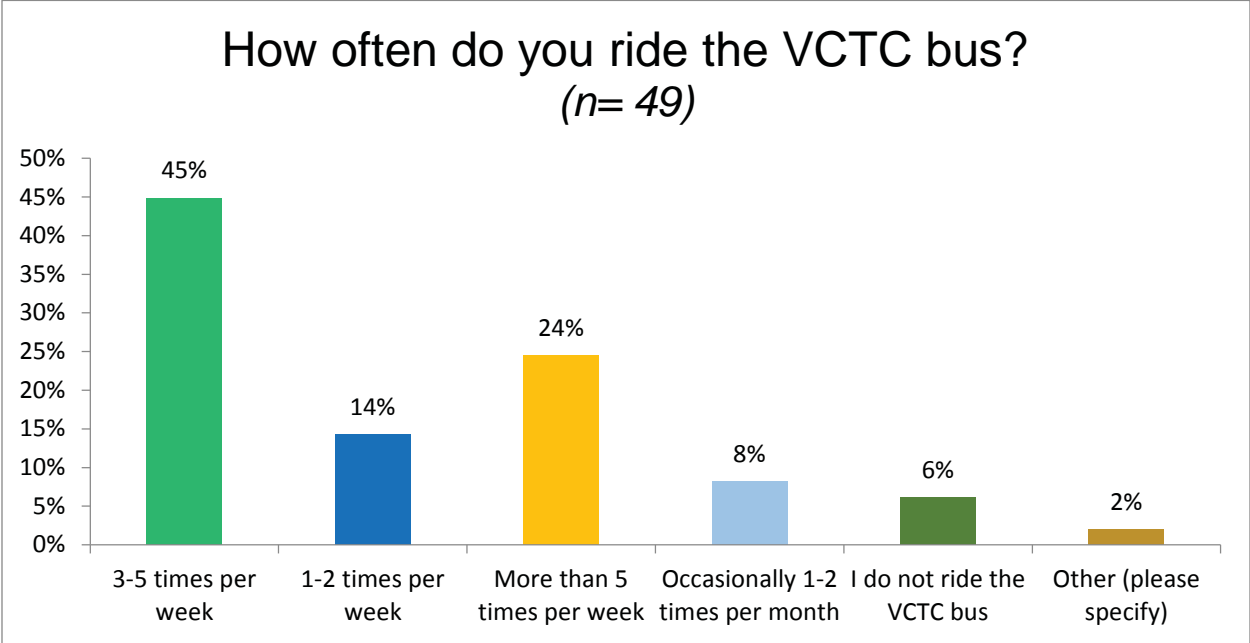
In sum, fifty-one (51) people provided VCTC comments during August 1, 2018 to August 29, 2018 time-frame. All of the responses came 100% entirely via the online bilingual web survey. Of the survey respondents, two (2) answered the survey in Spanish, the rest—49 responses—were completed in English.

The Online Bilingual Web Survey

Through the use of online service, *Survey Monkey*, a bilingual survey was prepared and hosted in both English and Spanish. VCTC has used this service previously, such as during the Annual Unmet Needs Transit Process.

In total, the survey was 10 questions long. Specifically, two questions were developed to provide statistical data regarding VCTC system usage and overall impact of the proposal (see below). The remaining questions collected open-ended feedback regarding each of the proposed increases or changes. All individual survey responses are enclosed as an appendix to this report.

After taking the survey, I now know that higher operational costs are the main reason for the fare hikes. I would recommend the use of conventional 40' transit buses with seats similar to those on current VCTC motorcoaches. The use of these conventional buses would reduce operating costs, as they use less fuel and need less repairs. These new buses would also be more maneuverable on narrow streets and offer more standing room than current motorcoaches can. New Flyer, NovaBus, Gillig, and Eldorado are manufacturers that offer conventional 40' diesel buses with commuter configurations. San Luis Obispo RTA and Kern Transit are also operators of countywide intercity bus service, similar to VCTC, that use these conventional vehicles.
