SUBJECT: ACTIVE TRANSPORTATION PROGRAM (ATP) CYCLE 4 LOCAL PRIORTIZATION METHODOLOGY

RECOMMENDATION:

• Approve a methodology to prioritize local projects for funding under the Metropolitan Planning Organization (MPO) Component of the ATP Cycle 4 Call-for-Projects (Attachment 1).

BACKGROUND:

The California Transportation Commission (CTC) has issued the ATP Cycle 4 Call-for-Projects. A synopsis of the ATP Cycle 4 Program is provided in the Fact Sheet in Attachment 2. The budget for Cycle 4 is anticipated to be approximately \$440 million and will cover fiscal years 19/20, 20/21, 21/22 and 22/23. Applications were due to Caltrans by July 31, 2018. Eleven (11) applications were submitted from Ventura County requesting a total of \$15,195,000.

How projects are selected for funding: Caltrans/CTC reviews all ATP project applications and scores are assigned to each application based on the adopted CTC Scoring Criteria. Applications can receive a maximum of 100 points.

According to the ATP Guidelines, program funding is segregated into three components and is distributed as follows:

- 50% to the state for the statewide competitive program (approximately \$220 million)
- 10% to small urban and rural regions (does not apply to Ventura County)
- 40% to Metropolitan Planning Organizations (MPO) (Southern California Association of Governments (SCAG) share is estimated is \$87.5 million)

<u>Statewide Competitive Program</u>: Once the applications are scored by Caltrans/CTC, the projects are ranked. Those projects with the highest ranking that can be funded with the roughly \$220 million available will receive funding through the statewide competitive program. <u>Regional Program (Ventura County's Estimated Population Share is \$3.7 Million)</u>: If projects do not score high enough to be funded under the Statewide Program they are reconsidered for funding through the MPO regional project selection process. For Ventura County the MPO Project Selection process is handled by SCAG.

DISCUSSION:

As in past years SCAG has developed Regional Guidelines for distribution of the region's estimated \$87.5 million share. Ventura County's share (based on population) is estimated to be roughly \$3.7 million according to SCAG estimates.

VCTC's role in the regional project selection process:

- The SCAG guidelines allow VCTC to develop a methodology to prioritize local projects for funding that flows through SCAG. As a means of prioritizing projects, Counties can add up to twenty (20) points to supplement the CTC scores.
- The Commission is required to adopt the final recommended project list for the County, and
- This year staff is also recommending VCTC adopt a Contingency List of Projects that will allow VCTC to substitute unfunded projects that are ready to proceed in case not enough funds are available to allow the threshold project to advance or if funds are made available through project cancellations or savings (subject to CTC approval).

Recommended 20 Point Criteria:

In the past cycles, VCTC has awarded points:

- 1. If a project was identified in an adopted plan, and
- 2. If the project was a Safe Routes to Schools Project.

This year staff is proposing to add a third category for awarding points for the preparation of an Active Transportation Plan. Plans are an eligible for funding in the ATP program and play a critical role in the CTC 100-point scoring criteria. Adding points to this project category would allow these projects to compete on an even playing field with other ATP eligible projects.

The recommended 20-point award criteria are provided in the Table in Attachment 1.

Next Steps: This item will be brought to VCTC for consideration at the October 5, 2018 Meeting. If approved, staff will return to Board for adoption of the final list of projects and contingency list of projects.

Active Transportation Program Cycle 4 Fact Sheet

ATP Program Goals:

The Active Transportation Program (ATP) was created by Senate Bill 99 (Chapter 359, Statutes of 2013) and by Assembly Bill 101 (Chapter 354, Statutes of 2013) to fund projects that increase and promote bicycle and pedestrian trips.

- Increase the proportion of trips accomplished by biking and walking,
- Increase safety and mobility for non-motorized users,
- Advance the active transportation efforts of regional agencies to achieve greenhouse gas reduction goals,
- Enhance public health,
- Ensure that disadvantaged communities fully share in the benefits of the program, and
- Provide a broad spectrum of projects to benefit many types of active transportation users.

Eligible Applicants:

- Local, Regional or State Agencies
- California Department of Transportation (Caltrans)
- Transit Agencies
- Public Schools and School Districts
- Public land and Natural Resource Agencies including Park Districts
- Tribal governments
- Non-profits eligible for Recreational Trail Program funds for projects that benefit the general public

Eligible Projects:

- Bicycle and Pedestrian infrastructure projects
- Non-infrastructure projects including education, encouragement, enforcement, and Safe Route to Schools Programs.
- Active Transportation Plans

Cycle 4 Funding Estimate:

The budget for Cycle 4 is anticipated to be approximately \$440 million and will cover fiscal years 19/20, 20/21, 21/22 and 22/23.

Funding Breakdown:

According to the ATP Guidelines, funding is segregated into three components and is distributed as follows:

- 50% to the state for the statewide competitive program
- 10% to small urban and rural regions with populations under 200,000
 - 40% to Metropolitan Planning Organizations (MPO) with populations over 200,000. • SCAG is the MPO for Ventura County
 - SCAG estimates indicates approximately \$87.5 million will be available for the SCAG region
 - Ventura County's population based share is roughly \$3.7 million

Schedule:

- May 16, 2018 -- Call-for-Projects Issued
- July 31, 2018 -- Applications Due to Caltrans

- January 2019 -- California Transportation Commission (CTC) Adopts the Statewide and Small Urban and Rural Portions of the program
- January 2019 -- Projects not Programmed by the CTC are distributed to the large MPOs for Consideration under the MPO Portion of the Program
- February 2019 -- MPO's Submit Draft Project Recommendations to the CTC
- June 2019 CTC Adopts the MPO Selected Projects

Summary of how projects are selected for funding:

Applications were due to Caltrans /CTC on July 31, 2018. Caltrans/CTC reviews all ATP project applications and scores are assigned to each project application based on the Caltrans/CTC Scoring Rubric. Applications can receive a maximum of 100 points.

<u>Statewide Competitive Program (50% of funding)</u>: Once the applications are scored by Caltrans/CTC, the projects are ranked. Those projects with the highest ranking that can be funded with the approximately \$220 million available will receive funding through the statewide competitive program.

<u>Regional Program</u>: Those projects that don't make the cut-off for the statewide competitive program are forwarded to the MPO's for consideration under the Regional Program.

SUBJECT:	STATUS OF FEDERAL SURFACE TRANSPORTATION PROGRAM (STP) AND CONGESTION MIGITATION AND AIR QUALITY (CMAQ) PROJECTS / PROGRAMMING OF CMAQ SHELF LIST AND COST INCREASES

RECOMMENDATION:

- Review and update project schedules.
- Recommend VCTC approve the programming of: (1) \$400,000 from the approved CMAQ Shelf List for design of the Springville Road Bike Path in Camarillo; and (2) \$280,370 for increased cost for the Rancho Road Bicycle/Pedestrian Project in Thousand Oaks.

DISCUSSION:

Under federal law, STP and CMAQ funds apportioned to California lapse if they are not used within three years. AB 1012, which became law in October 1999, applies the three-year lapsing rule to CMAQ and STP funds in each county. It is important for VCTC to have an accurate schedule of STP and CMAQ (Attachments 1 and 2, respectively) projects to ensure that our region does not lose funds. VCTC also uses this project schedule to ensure that the Federal Transportation Improvement Program (FTIP) includes all of the projects which are ready-to-go and to manage the county's Obligational Authority (OA).

An additional issue for FY 2018/19 is that the federal FAST Act provides for a rescission based on the unobligated CMAQ apportionment balance at the end of FY 2018/19. As a result, VCTC should consider how to reduce the Ventura County unobligated CMAQ balance to minimize the impact of the rescission on the county. VCTC sent the attached notice to agencies on August 28th, requesting information on the status of their CMAQ and STP projects, along with information on possible strategies to increase the amount to be obligated in FY 2018/19 if necessary to minimize the rescission.

Based on the response to the request to agencies to provide CMAQ and STP project statuses, staff has prepared the attached tables showing the status of programmed projects. It appears that \$10,336,772 in CMAQ funds is scheduled to be obligated in FY 2018/19, leaving an estimated balance of \$8,535,314. The issue for consideration is that this balance is subject to a

proportional share in the rescission scheduled in the FAST Act. The actual proportion of the unobligated balances to be rescinded will be based on the nationwide unobligated balance, which will not be known until that time. Although there is little STP funding to be obligated in the upcoming year, due to the recent loan to Orange County there is no immediate danger of lapsing funds, and the FAST Act rescission is not expected to apply to the STP balance. However, additional loans will be required no later than FY 2019/20. As has been previously discussed, the Orange County loan and the planned future loans will be paid back when required to facilitate construction of the Route 101 Early Action Improvements.

The responses to VCTC's request indicated that the following funds on the CMAQ Shelf List can obligate funds in FY 2018/19, thus reducing the unobligated balance:

- Gold Coast Bus Engine Replacement \$1,451,095
- Gold Coast Ventura Road New Service \$1,218,047
- Camarillo Springville Road Bike Path Design \$400,000

In addition, Thousand Oaks responded with a request to increase the CMAQ funds for the Rancho Road project by \$280,370. TRANSCOM at its September 13th meeting recommended VCTC approval of the two Gold Coast Transit projects on the Shelf List. The cumulative effect of obligating these additional funds in FY 18/19 will be to reduce the end-of- fiscal-year obligated balance to \$5,185,802. Should any of the CMAQ projects shown on the table for 18/19 not be obligated on this schedule, the result would be to increase the amount of this unobligated balance subject to a proportional rescission.

In its response to the request for a project status update, Camarillo suggested that if the Springville Road scope could be expanded beyond the project as defined in the Shelf List, it could obligate an additional \$800,000 in FY 2018/19. The Committee may wish to consider possibly approving additional CMAQ projects that can be obligated in 2018/19 but were not selected or placed on the shelf list in the CMAQ call for projects.

It is important to note that although this action will significantly reduce the rescission impact on Ventura County, this is not "free money." Funds from the balance that are not rescinded will carry over to FY 2019/20 and be available for the CMAQ projects (primarily bicycle/pedestrian) that could not obligate funds by 2018/19. Although the use of \$3,349,512 for the Shelf List and the cost increase will reduce the amount of the rescission, thus keeping the money in the county, the portion of those funds that were not going to be rescinded will no longer be available to carryover and pay for the projects delivered in FY 2019/20 and beyond. As result, there will be a decrease in the funding available in the next CMAQ call for projects.

SUBJECT: REQUEST FOR STATUS UPDATE FOR CMAQ AND STP PROJECTS / POSSIBLE AVAILABLE FUNDS FOR CMAQ SHELF LIST & COST INCREASES

VCTC requests your assistance to provide the project status and fund obligation schedule for projects programmed for the federal Congestion Mitigation and Air Quality (CMAQ) program and the Regional Surface Transportation Program (STP). This information is particularly critical this year because the Fixing America's Surface Transportation (FAST) Act, passed in 2015, includes a provision to rescind a portion of unobligated CMAQ apportionment balances remaining unobligated at the end of FY 2018/19. To minimize the effect of this rescission on Ventura County it will be necessary to lower the CMAQ balance as much as possible. Furthermore, projected STP and CMAQ obligation schedules assist Caltrans in managing statewide obligation authority.

Based on the CMAQ project schedule information provided to VCTC, if there appears to remain a significant unobligated CMAQ balance, VCTC will, in consultation with TTAC and TRANSCOM, consider possible steps to lower the CMAQ balance, possibly including: (1) funding projects or project phases on the attached Shelf List that can obligate funds by September 30, 2019, the end of federal FY 2018/19; or (2) increasing funding for approved or Shelf List projects provided that the increased funds can be obligated by September 30, 2019.

So that VCTC can address these issues, please provide the following information to VCTC staff by **September 10, 2018**:

- 1. On the enclosed spreadsheets, update the information for your projects shown in the "Planned Obligation Date" and "Current Project Status" columns.
- 2. If your agency is recommending the programming of additional CMAQ funds that can be obligated by September 30, 2019, provide a letter, signed by yourself, specifying the requested funds, including funds on the Shelf List that can be obligated by the deadline, or additional CMAQ funds needed by approved CMAQ project scopes or CMAQ shelf list scopes. (Please note that your agency will still need to provide the local match amount committed to the project in your original application.)

Staff expects to come to the September TTAC and TRANSCOM meetings with the updated tables of STP and CMAQ project statuses and a recommendation for addressing the pending CMAQ rescission.

SUBJECT: UPDATE ON SENATE BILL 1 PUBLIC INFORMATION

RECOMMENDATION:

• Review and discuss.

BACKGROUND:

The state has committed (assuming Proposition 6 does not pass) the following to Ventura County over the next five years from SB 1:

- \$120 million for the ten cities and counties to better maintain their streets and roads.
- \$69 million to provide the funds needed to complete the Rice Avenue Bridge over the railroad at Fifth Street in Oxnard.
- \$25 million for transit operations and maintenance.
- \$3.4 million for active transportation (bicycle/pedestrian) projects.

In addition to these specific SB 1 commitments in Ventura County, the county will benefit from the following other transportation programs that are committed for funding at least in part by SB 1, and include work within or in close proximity to this county. However, these funds will be at risk should Proposition 6 pass:

- \$5.75 billion over the next five years statewide for rehabilitating state highways.
- \$764 million for the Metrolink SCORE project to expand system capacity, including Ventura County Line improvements in the vicinity of Simi Valley.
- \$247 million to widen the Route 5 Freeway in Santa Clarita in Los Angeles County.
- \$148 million for capacity and reliability enhancements to the LOSSAN North ("Amtrak Pacific Surfliner") Corridor between Los Angeles and San Luis Obispo, including improvements in Oxnard and Camarillo.
- \$104 million to widen the Route 101 Freeway through Carpinteria and Summerland in Santa Barbara County.
- \$9.6 million for enhanced bus service between Ventura County, Santa Barbara, and Goleta.

As the Committee is aware, VCTC has put on its <u>www.goventura.org</u> website a map showing the location of projects funded by SB 1 within Ventura County. VCTC staff recently requested information on the FY 2018/19 Local Streets and Roads projects, and the approved projects for which information was received have now been posted on the VCTC website. This information is in addition to the FY 2017/18 Local Streets and Roads projects, along with projects funded from other SB 1 programs, that were previously posted on the website. Caltrans also provides SB 1 project information on its <u>www.rebuildingca.ca.gov</u> website, but on that website the project mapping is primarily for Caltrans projects, with local agency projects generally shown at the location of the agency's headquarters, or (for Active Transportation) at the location of the MPO's headquarters.

It is recommended that TTAC members provide an update at the meeting on their agencies' efforts to provide public information regarding SB 1.

BACKGROUND:

Local Streets and Roads Reporting:

Reports of FY17-18 Local Streets and Roads expenditures are due to the California Transportation Commission (CTC) October 1st. The new online reporting tool can be found on the CTC website at: <u>http://www.catc.ca.gov/programs/sb1/lsrp/</u>

California Conservation Core ATP Funding

Under SB1, the CCC receives \$4 million annually of SB1 funding through the ATP program.

The first round of funding approved in the Cycle 3 Augmentation included the first two years of SB1 funding (\$8 million). Projects primarily included Trail Improvements and Rehabilitation.

The CCC plans to issue their Cycle 4 Call-for-Projects in late November. Projects are intended to include CCC supervised crews of 10-15 young adults trained and equipped to work on ATP. Projects can include:

- Trail construction
- Urban park development
- Demolition and deconstruction
- Sign installation
- Irrigation and landscaping including tree planting
- Bike locker installation and repair
- Education and outreach

- Sidewalk repair, removal and replacement
- Scenic overlook construction

Corridor Planning

SB1 allocates \$250 million annually to reduce congestion on highly traveled and highly congested corridors. All projects nominated for the Congested Corridors Program must be in a multimodal corridor plan. This prompted Caltrans to develop guidance for Corridor Planning.

Caltrans is currently preparing the <u>Corridor Planning Guidebook</u> to be used by Caltrans in partnership with local agencies to develop long-range, multi-modal corridor plans associated with the state highway system. This is important to local agencies looking to improve Caltrans facilities within their local jurisdictions.

VCTC will be following the development of the Corridor Planning guidelines for the Route 101 Corridor Planning Project and will provide information back to TTAC periodically on the status of the project.

SCAG 2018 Planning Grants - Call-for-Projects

The Southern California Associations of Governments is accepting applications for the 2018 Sustainable Communities Program: <u>http://sustain.scag.ca.gov/Pages/DemoProjApplication.aspx</u>

The goals of the Program include:

- Provide needed planning resources to local jurisdictions for sustainability planning;
- Develop local plans that support the implementation of the 2016 RTP/SCS; and
- Increase the region's competitiveness for federal and state funds, including but not limited to the California Active Transportation Program and Greenhouse Gas Reduction Funds.

These planning grants are important to local agencies as they help to ready projects for new funding opportunities. Projects further along in the planning and design process tend to do well in highly competitive grant program Calls-for-Projects.

Caltrans FY 19/20 Sustainable Communities Planning Grants

Caltrans is getting ready to issue a Call-for-Projects for Sustainable Planning Grants. Final Grant Application Guides are anticipated for release in early October, and applications will be due in late November 2018.

Types of projects funded in the last round included:

- Active Transportation Plans
- Corridor Master Plans and Specific Plans for Corridors
- Complete and Sustainable Streets Plans to transform arterials into a high quality multimodal corridor.
- Engineered Feasibility Studies

These planning grants are important to local agencies as they help to ready projects for new funding opportunities. Projects further along in the planning and design process tend to do well in highly competitive grant program Calls-for-Projects.
