ITEM 8 FAST ACT RESCISSION STATUS

Ms. Johnduff updated the Committee with the latest information from Caltrans that due to the rush of agencies attempting to draw down apportionments, the budget authority to obligate funds is virtually gone, after subtracting out projects currently at Caltrans Headquarters that are not yet obligated. She said that based on the attached table it appears that the efforts of Ventura County agencies to quickly draw down the CMAQ balance have resulted in a remaining balance of under \$1 million. She reiterated, based on statements of Caltrans staff there should be enough budget authority remaining to obligate all projects shown on the table as currently being at Caltrans Headquarters. However, the situation remains fluid and VCTC is staff is closely monitoring the status of these projects and of the CMAQ funds.

Staff requests local jurisdictions to review the attached table and report on any possible changes or errors to help ensure that VCTC has an accurate picture of the current CMAQ balance.


SUBJECT: US-101 MULTIMODAL CORRIDOR STUDY

RECOMMENDATION:

Receive information and a presentation on the US-101 Multimodal Corridor Study.

BACKGROUND:

Ventura County Transportation Commission (VCTC) and Southern California Association of Governments (SCAG) are initiating the US-101 Multimodal Corridor Study (Study). The Study will provide consensus-based recommendations for multimodal mobility enhancements to benefit the communities along US-101 in Ventura County. The proposed study area includes the US-101 Freeway and the area generally up to three (3) miles on either side of the freeway as shown in Figure 1. The completion of this Study will make Ventura County eligible to compete for state funding to implement these recommendations including funds from the SB 1 Solutions for Congested Corridors Program (SCCP) program.



Iteris, Inc. is the prime consultant firm leading the multi-disciplinary team for this project. The Study began in July 2019 and is anticipated to take approximately 12-months to complete.

In developing the Study, a comprehensive list of potential transportation improvements will be developed, from various sources, for all modes of transportation within the study area, with assistance and guidance from community stakeholders including the VCTC's Transportation Technical Advisory Committee (TTAC). These potential improvements will be grouped into three (3) alternative packages with consideration to achieve a balance between cost, feasibility and anticipated benefits, and will be evaluated by their potential to improve safety, congestion, accessibility, economic development, air pollution including reduction in greenhouse gas emissions, and efficient land use.

These alternative packages will be presented to project and community stakeholders to gain feedback on the individual elements of the alternatives and the packages as a whole. The Iteris Team will then prepare and present the concept alternatives, a draft plan and the final plan for adoption by the VCTC and its TTAC. The completed Final US-101 Multimodal Corridor Study will provide a clear vision and roadmap for the US-101 corridor in Ventura County with systematic strategies to achieve greater mobility, increased economic opportunity and better quality of life for all of the corridor's residents, employees, visitors and travelers.

In preparing the Study, a comprehensive public engagement process, planning analysis and a process to select the preferred alternative will be completed. Throughout this process, regular engagement and feedback from the TTAC and Community Stakeholders are expected in the following areas:

Data Collection

The Iteris Team will identify and compile a list of data and information needed to support the goals and objectives of this effort including but not limited to demographics, traffic volumes and patterns, transit ridership, non-motorized travel and land use/zoning plans. As part of the process, Iteris will contact the TTAC members to collect the latest data and information.

Goals and Objectives / Performance Measures / Concept Alternatives

The Iteris Team, in consultation with the TTAC and the Transit Operators Advisory Committee (TRANSCOM), will develop a multimodal framework to assess the transportation projects as a holistic system and assist the stakeholders to understand the challenges, opportunities, benefits and costs associated with different projects.

The Framework will be aligned with VCTC's vision as stated in the Ventura County 2013 Comprehensive Transportation Plan (CTP) and it will be consistent with the California Transportation Commission's (CTC) Comprehensive Multimodal Corridor Plan Guidelines. The Framework will also be based on Caltrans' Smart Mobility Framework (SMF) approach with focus on the Ventura County's transportation system purpose and need developed for mobility in the 101 Corridor.

Using the Framework, three sets of transportation system packages /alternatives will be developed. Their effectiveness will be measured and compared across the goals identified in the Framework based on a set of performance measures developed in consultation with TTAC and other stakeholders. The TTAC is requested to provide recommendations and approvals.

Outreach and Stakeholder Engagement

One key element of the project is the public and stakeholder involvement and engagement in the process. The Iteris Team in close coordination with SCAG and VCTC, will host several community meetings, workshops, and

targeted briefings to update the US-101 corridor communities on the progress of the project and solicit their feedback at key intervals on alternatives. Digital public engagement (e.g. Website, Surveys, and Digital Engagement Campaign) will also be conducted to reach a wide range of community stakeholders.

DISCUSSION:

VCTC staff and Mr. Viggen Davidian of Iteris Inc. will be presenting an overview of the US-101 Multimodal Corridor Study.

SUBJECT: ALLOCATION OF FISCAL YEAR (FY) 2019/20 TRANSPORTATION DEVELOPMENT ACT (TDA)

ARTICLE 3 BIKE PATH MAINTENANCE FUNDS

RECOMMENDATION:

• Approve the allocation of Fiscal Year 2019/2020 Transportation Development Act (TDA) Article 3 Bike Path Maintenance Funds totaling \$182,958 as shown in the attached Table.

BACK GROUND:

Pursuant to California PUC Section 99233.3, two percent (2%) of Transportation Development Act (TDA) Local Transportation Funds are set aside for planning, constructing and maintaining bicycle and pedestrian facilities. In Ventura County 25% of the TDA Article 3 Bicycle/Pedestrian funds are set aside for maintenance of Class I pathways based upon the proportional share of pathway miles within each jurisdiction. The remainder of the annual TDA Article 3 Bicycle/Pedestrian funding is allocated on a competitive basis for projects that foster an increase in bicycling and walking.

DISCUSSION:

This year there is an estimated \$182,958 (25%) of FY19/20 Article 3 funds available for distribution to local jurisdictions for Class I Bike Path maintenance. Agencies were asked to review and update the mileage information for their jurisdictions. The attached table provides a breakdown of Class I Bicycle Path mileage for each jurisdiction and their proportional share of the FY19/20 TDA Article 3 maintenance funds.

SUBJECT: 2020 STATE TRANSPORTATION IMPROVEMENT PROGRAM (STIP) SUBMITTAL

RECOMMENDATION:

Approve the 2020 STIP submittal to the California Transportation Commission.

BACK GROUND:

State law requires the adoption and submittal of a five-year State Transportation Improvement Program (STIP) by December 15 of each odd-numbered year. The Ventura County Transportation Commission (VCTC) is the agency responsible for developing the STIP for Ventura County working cooperatively with Caltrans. The STIP is comprised of a five-year list of capital improvement projects to be funded from VCTC's share of STIP Regional Improvement Program (RIP) funds for the period starting July 1, 2020 (FY20/21) and ending June 30, 2025 (FY 24/25).

The 2020 STIP for Ventura County is due to the California Transportation Commission (CTC) on December 15, 2019. Projects to be included in the STIP must be submitted to SCAG for modelling no later than September 24th. The CTC is responsible for reviewing and approving STIP submittals. The CTC is scheduled to publish the 2020 STIP staff recommendations on February 28, 2020, and adopt the 2018 STIP on March 25, 2020.

DISCUSSION:

In recent memory, there was significant variability in funding available from one STIP cycle to the next. However, SB 1, passed in 2017, stabilized STIP funding by indexing the state fuel tax to inflation, rather than to the fuel price as had been the previous policy for the fuel tax that supported the STIP. Although the 2020 STIP has significantly less programming capacity than the 2018 STIP, the reduction is mostly caused by extensive advanced allocations that did not change the total amount of funding but changed the timing of those funds, with less projected to be available during the upcoming STIP period. As a result, in future STIPs the available programming capacity is expected to recover to a level that is only slightly less than what was in the 2018 STIP.

The slight reduction in the long-term projection is caused by gradually decreasing fuel consumption leading to reduced fuel tax revenues.

PROPOSED 2016 PROGRAM

Planning, Programming & Monitoring (PPM)

PPM is utilized annually by VCTC to fund planning and programming activities performed by VCTC staff and consultants, and can be programmed up to a maximum of 5% of the county share. There is \$518,000 in new programming capacity for PPM over the last two years of the STIP. Due to the reduced county share availability in the 2020 STIP, as already described, the amount available for the last two years is significant less than what was programmed for earlier years. Since the next STIP cycle is anticipated to recover most of the prior funding capacity, staff recommends that the 2020 STIP contain only a slight reduction for PPM in the first two years, with the expectation that the larger reduction programmed for later years can be adjusted upwards in the 2022 STIP submittal. The recommended PPM program submittal is summarized in the following tables.

Route 101 Construction

Under VCTC's adopted policy, the Route 101 Improvement project is the priority for STIP as well as federal Surface Transportation Program (STP) funds. Without a source of local funds, these state and federal resources can only provide a relatively small portion of what is required for the full project. However, upon completion of the environmental document currently underway, it will be possible to program whatever funds have accumulated for "Early Action" improvements to 101. Therefore, after programming \$518,000 of new STIP funds for PPM, the remaining \$60,675,000 in the Ventura County share can be carried over to the future. It is anticipated that the Route 101 environmental clearance will have proceeded sufficiently to allow the nomination of a specific Early Action improvement phase of the Route 101 Improvement Project for the 2022 STIP, with construction funds for construction likely becoming available in FY 25/26.

Meanwhile, staff estimates that by 2021 there will be over \$70 million in Surface Transportation Program (STP) funds available that should be sufficient to fund the pre-construction phases of the Early Action Items on 101 that can be accomplished with the available funding. The state apportions these funds to counties from the federal Surface Transportation Block Grant (STBG) program which stipulates that funds apportioned to states lapse if not used within three years of appropriation. State law applies this three-year lapsing rule to the county STP apportionments. Since STP is commonly used for large projects that require multiple years of apportionment, California counties routinely "loan" apportionments to each other to prevent a lapse. Because of this need to carryover a large STP balance over multiple years, the Commission has approved loans of \$21.5 million to Orange County and \$14.3 million to San Bernardino County, with both loans scheduled to be repaid in September, 2021 so that these funds will be part of the \$70 in STP funds available at that time for the 101 project.

SUBJECT: STATUS OF FEDERAL SURFACE TRANSPORTATION PROGRAM (STP) AND CONGESTION

MITIGATION, AND AIR QUALITY (CMAQ) PROJECTS

RECOMMENDATION:

Review and update project schedules.

DISCUSSION:

Under federal law, STP and CMAQ funds apportioned to California lapse if they are not used within three years. AB 1012, which became law in October 1999, applies the three-year lapsing rule to CMAQ and STP funds in each county. It is important for VCTC to have an accurate schedule of STP and CMAQ (Attachments 1 and 2, respectively) projects to ensure that our region does not lose funds. VCTC also uses this project schedule to ensure that the Federal Transportation Improvement Program (FTIP) includes all of the projects which are ready-to-go and to manage the county's Obligational Authority (OA).

Attached is the current status of obligation projects during the current Federal Fiscal Year (FFY) as well as anticipated FFY) 2019/20 schedule. Staff requests that agencies with CMAQ or STP projects inform staff regarding the statuses of these projects and in particular whether the anticipated obligation dates shown in FFY 2019/20 are correct, and if there are any other projects scheduled to be obligated in 2019/20 that are currently shown in later years. It should be noted that the Federal Fiscal Year is defined as the period from October 1st to September 30th, and the obligation date is defined as the date that the federal government issues the authorization for a project phase to proceed.

At this time there appears to be no problem with funds lapsing for Federal Fiscal Year 2019/20. There are also sufficient CMAQ projects in the pipeline to obligate the required funds in FFY 2020/21. There is \$6,189,790 in STP potentially lapsing at the end of FFY 2020/21, and since the Route 101 project is not anticipated to require additional funds until final design which is scheduled to start in FFY 2021/22, VCTC will need to continue to look to "loaning" apportionment to another county, thus resetting the deadline for those funds.

SUBJECT: PROPOSED FEDERAL FUEL EFFICIENCY RULE CHANGE

RECOMMENDATION:

Review and discuss.

DISCUSSION:

As was discussed at the last Committee meeting, the Trump Administration has proposed a rule that would overrule California's fuel efficiency standard and establish a single national standard that will be a reduction from the current requirement. This reduction of the future fuel efficiency requirement would cause California to lose its conformity with the Clean Air Act, potentially triggering a restriction of federal transportation funding.

The rule would stipulate that the California Air Resources Board cannot establish a separate fuel efficiency standard, nor could other states elect to adopt California's standard. It would freeze the standard at the existing level through 2025. Unlike other states that use California's emissions standards, California's State Implementation Plan for air quality relies on modeling that assumes the currently-adopted fuel efficiency standard, so if the federal government reduces that standard, California will be out of compliance with the Clean Air Act, and therefore will be unable to receive required federal approvals for regionally-significant transportation projects.

The specific impact of the rule on transportation funding is difficult to determine. Since air quality conformity is a general requirement for NEPA determinations and TIP amendments (other than administrative modification), it might not be possible for these actions to happen, although the timing of the impact is uncertain. Eventually, the lack of air quality conformity would lead to federal sanctions that would cut off funds for certain regionally-significant transportation projects.

This federal rule is currently at the final stage of the approval process, which is Office of Management and Budget review.
