SUBJECT: SENATE BILL 743 IMPLEMENTATION IN VENTURA COUNTY

RECOMMENDATION:

• Receive a presentation on implementation of Senate Bill (SB) 743 by VCTC and Ventura County jurisdictions.

BACKGROUND:

In 2013, the California State Legislature passed Senate Bill (SB) 743, which prohibits use of automobile delay (measured by Level of Service) in analysis of transportation impacts under the California Environmental Quality Act (CEQA). Local agencies have until July 1, 2020 to implement SB 743. The intent of SB 743 is to "more appropriately balance the needs of congestion management with statewide goals related to infill development, promotion of public health through active transportation, and reduction of greenhouse gas emissions."

SB 743 also requires the Governor's Office of Planning and Research (OPR) to identify new metrics for identifying and mitigating transportation impacts within CEQA. In December 2018, OPR issued a Technical Advisory containing its recommendations for a shift from LOS to Vehicle Miles Travelled (VMT), and the Department of Natural Resources issued updated CEQA guidelines for analysis of transportation impacts on the environment.

For transportation projects, lead agencies for roadway capacity projects have discretion, consistent with CEQA and planning requirements, to choose which metric to use to evaluate transportation impacts. Caltrans selected VMT as its metric as well. Caltrans guidance documents, including Transportation Analysis Framework (TAF) and Transportation Analysis under CEQA (TAC), are currently available for public review and comment through June 15, 2020.

DISCUSSION:

VCTC's Director of Planning & Policy, Amanda Fagan, will present a brief overview of SB 743 and the status of implementation efforts by VCTC and jurisdictions across Ventura County.

SUBJECT: ACTIVE TRANSPORTATION PROGRAM - 2020 INTERIM TIMELY USE OF FUNDS POLICY

RECOMMENDATION:

Information

BACKGROUND AND DISCUSSION:

The California Transportation Commission (CTC) has adopted an Interim Timely Use of Funds Policy to address impacts to project delivery as a result of the COVID-19 pandemic. The Interim Policy includes:

Project Allocations--the deadline to request an allocation for projects programmed in FY19-20 has been extended to the December 2020 Commission meeting. This will be automatic and no additional action by the agency is necessary.

Construction Contract Award--The period to award contracts for projects that receive a construction allocation through December 2020 has been extended to 12-months. This extension also includes projects that received an allocation in October 2019, December 2019, January 2020. Caltrans will bring this action before the CTC and no action is required on the agency's part.

Final Invoice--For allocations with the 180-day deadline for final invoicing expiring in May 2020 through December 2020, the deadline has been extended for an additional 180 days. This will be automatic, and no action is required from the agency.

Preconstruction Expenditures--For projects needing an extension for the expenditure of preconstruction funds, a normal expenditure deadline time extension <u>is</u> required and the agency must request the time extension through the normal process.

Request for Time Extensions-- The maximum time extension for the following milestones: expenditure, construction contract award and project completion has been extended from 12

months to 20-months. A one-time time extension amendment will be considered for projects with an approved time extension that expires in May 2020 through December 2020 to extend the period of the time extension to up to 20-months. The CTC will consider extending the deadline beyond the 20-months for current time extensions that are expiring March 2020 to February 2021 and the agency will need to submit a time-extension request.

The timely use of funds provisions are intended for the period of delay directly attributed to COVID-19. The Interim Timely Use of Funds Policy expires December 31, 2020.

SUBJECT: ACTIVE TRANSPORTATION PROGRAM CYCLE 5 – REGIONAL PROJECT SELECTION CRITERIA FOR THE MPO COMPONENT

RECOMMENDATION:

• Information and Discussion

BACKGROUND AND DISCUSSION:

The CTC has extended the due date for the Active Transportation Program (ATP) Cycle 5 Project Applications. The new application due dates are:

- Quick-Build Project applications deadline (postmark date) July 15, 2020
- All other project applications deadline (postmark date) September 15, 2020

A Fact Sheet is attached (Attachment 1) with background information on the Cycle 5 ATP program including project eligibility, funding estimates, and links to helpful application resources.

<u>Letters of Support for Cycle 5 Projects</u>: If an agency is requesting a letter of support from VCTC to submit with their application, the project will be reviewed for consistency with the local and regional plans and the initial work schedule will be reviewed for feasibility in relation to the time constraints of the ATP Program.

MPO COMPONENT

Regional Project Selection:

The Cycle 5 ATP funding estimates for the SCAG region is \$93.4 million, of which the Ventura County share is estimated to be \$3.9 million. The impact of Covid-19 on the program has not yet been determined.

VCTC's role in the regional project selection process:

- The SCAG guidelines allow VCTC to develop a methodology to prioritize local projects for funding that flows through SCAG. As a means of prioritizing projects, Counties can add up to twenty (20) points to supplement the CTC scores,
- The Commission is required to adopt the final recommended project list for the County, and
- This year staff is also recommending VCTC adopt a Contingency List of Projects that will allow VCTC to substitute unfunded projects that are ready to proceed in case not enough funds are available to allow the threshold project to advance or if funds are made available through project cancellations or savings (subject to CTC approval).

Recommended 20 Point Methodology:

In Cycle 4, VCTC has awarded points based on two criteria:

- 1. Ten (10) points if a project was identified in an adopted plan listed in Attachment 2 and,
- 2. Ten (10) points If the project was a Safe Routes to Schools Project.

This year staff supports eliminating the Capital Improvement Program as a qualifying plan since it does not take the place of an adopted plan which goes through a city-wide/county-wide assessment and prioritization of needs and project recommendations with public input. Staff also supports requiring plans to be no more than 10 years old.

This item will be brought back to TTAC for consideration in June. Staff is requesting that agencies review the list of Plans in Attachment 2 and provide input on additions/deletions to the list of plans.

SCAG Regional Disadvantaged Communities (DAC) Definition: Per the Statewide Guidelines, MPO's have the option to use different criteria for determining which projects benefit disadvantaged communities. The SCAG Regional DAC definition includes Environmental Justice Areas and Communities of Concern. These criteria can be used in addition to the existing SB 535 criteria in the application.

- Environmental Justice Areas: Environmental Justice Areas are reflected in Transportation Analysis Zones that show a higher share of minority population or households in poverty than is seen in the great region as a whole.
- Communities of Concern: Communities of Concern are Census Designated Places or city of Los Angeles Community Planning Ares that fall in the upper third for their concentration of minority population households in poverty. This designation is significant in severity due to the degree of poverty

Non-Infrastructure Projects: SCAG will again be reserving 5% off the top of the ATP MPO program funds for Planning and Non-Infrastructure Projects. As in previous cycles, the pool of projects considered for this funding in this category include projects that are submitted through the CTC's Statewide ATP Call for Projects using the state's planning application, as well as, planning and non-infrastructure projects submitted through SCAG's Sustainable Communities Program (SCP) program. Planning Project awards will be capped at \$500,000. Non-infrastructure and quick build projects awards will be capped at \$900,000.

Active Transportation Program Cycle 5 Fact Sheet

ATP Program Goals:

The Active Transportation Program (ATP) was created by Senate Bill 99 (Chapter 359, Statutes of 2013) and by Assembly Bill 101 (Chapter 354, Statutes of 2013) to fund projects that increase and promote bicycle and pedestrian trips.

- Increase the proportion of trips accomplished by biking and walking,
- Increase safety and mobility for non-motorized users,
- Advance the active transportation efforts of regional agencies to achieve greenhouse gas reduction goals,
- Enhance public health,
- Ensure that disadvantaged communities fully share in the benefits of the program, and
- Provide a broad spectrum of projects to benefit many types of active transportation users.

Eligible Applicants:

- Local, Regional or State Agencies
- California Department of Transportation (Caltrans)
- Transit Agencies
- Public Schools and School Districts
- Public land and Natural Resource Agencies including Park Districts
- Tribal governments
- Non-profits eligible for Recreational Trail Program funds for projects that benefit the general public

Eligible Projects:

- Bicycle and Pedestrian infrastructure projects
- Non-infrastructure projects including education, encouragement, enforcement, and Safe Route to Schools Programs.
- Active Transportation Plans

Cycle 5 Funding Estimate:

The budget for Cycle 5 is anticipated to be approximately \$445.5M and will cover fiscal years 2021/22, 2022/23, 2023/24, and 2024/2025.

Funding Breakdown:

According to the ATP Guidelines, funding is segregated into three components and is distributed as follows:

- 50% to the state for the statewide competitive program
- 10% to small urban and rural regions with populations under 200,000
- 40% to Metropolitan Planning Organizations (MPO) with populations over 200,000.
 - SCAG is the MPO for Ventura County
 - SCAG estimates indicates approximately \$93.4 million will be available for the SCAG region
 - Ventura County's population-based share is roughly \$3.9 million

Note: Funding estimates will be refined at a future date to reflect COVID-19 budget impacts.

Schedule:

- March 26, 2020 -- Call-for-Projects Issued
- July 15, 2020 -- Quick Build Applications Due
- September 15, 2020 All other Project Applications Due
- March 2021-- California Transportation Commission (CTC) Adopts the Statewide and Small Urban and Rural Portions of the program
- March 2021 -- Projects not Programmed by the CTC are distributed to the large MPOs for Consideration under the MPO Portion of the Program
- April 2021 -- MPO's Submit Draft Project Recommendations to the CTC
- June 2021 CTC Adopts the MPO Selected Projects

Summary of how projects are selected for funding:

Applications are due to Caltrans /CTC on September 15, 2020. Caltrans/CTC reviews all ATP project applications and scores are assigned to each project application based on the Caltrans/CTC Scoring Rubric. Applications can receive a maximum of 100 points.

<u>Statewide Competitive Program (50% of funding)</u>: Once the applications are scored by Caltrans/CTC, the projects are ranked. Those projects with the highest ranking that can be funded with the approximately \$222 million available will receive funding through the statewide competitive program.

<u>Regional Program</u>: Those projects that don't make the cut-off for the statewide competitive program are forwarded to the MPO's for consideration under the Regional Program.
