# MEMORANDUM OF USAGE AGREEMENT SANTA PAULA BRANCH (COUNTY OF VENTURA)

THIS MEMORANDUM OF USAGE AGREEMENT (this "Memorandum"), dated as of October 31, 1995, is entered into by SOUTHERN PACIFIC TRANSPORTATION COMPANY, a Delaware corporation ("Southern Pacific") and VENTURA COUNTY TRANSPORTATION COMMISSION ("VCTC").

#### Recitals

- A. Pursuant to a Purchase and Sale Agreement dated October 27, 1995, between Southern Pacific and VCTC (the "Purchase Agreement"), Southern Pacific has sold to VCTC and VCTC has purchased from Southern Pacific, certain property commonly known as Southern Pacific's Santa Paula Branch located in Ventura County, California and more particularly described in <a href="Exhibit A">Exhibit A</a> attached hereto (the "Property").
- B. Pursuant to the Purchase Agreement, Southern Pacific and VCTC have entered into a Usage Agreement -- Santa Paula Branch dated as of the date hereof (the "Usage Agreement"), whereby VCTC and Southern Pacific agreed upon the terms of the reservation by Southern Pacific of the usage rights retained for Southern Pacific's exclusive present and future rail freight service on the Property.
- C. Southern Pacific and VCTC now desire to execute this Memorandum for purposes of providing record notice of the Usage Agreement.

## Agreement

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereby agree as follows:

- 1. <u>Usage Rights</u>. Southern Pacific grants to VCTC those rights to use the Property provided under the Purchase Agreement and the Usage Agreement, except the usage rights reserved by Southern Pacific in the Usage Agreement.
- 2. <u>Ownership</u>. Ownership and use of any railroad tracks and related facilities located on the Property shall be as provided in the Usage Agreement.
- 3. <u>Effect of Memorandum</u>. This Memorandum is intended solely to provide record notice of the Usage Agreements, and shall not modify or amend any provision thereof. The Usage Agreement is hereby incorporated herein by reference with the same force and effect as if fully set forth herein. In the event of any conflict or inconsistency between the provisions of the Usage Agreement and the provisions of this Memorandum, the provisions of the Usage Agreement shall control.
