SAFE & Motorist Aid

- California Legislature established Service Authorities for Freeway Emergencies (SAFE) to encourage development of motorist aid system comprised of multiple service elements and infrastructure along the Freeway and Freeway System to enable motorists in need of assistance to obtain aid
- Ventura County Transportation Commission (VCTC) serves as the SAFE for Ventura County
- Funding provided by a \$1 annual vehicle registration fee on all vehicles registered in Ventura County
- Ventura County SAFE programs include:
 - Roadside Emergency Call Boxes
 - Freeway Service Patrol
 - Advance Traveller Information System (SpeedInfo)
 - Incident Responder Grant Program

Incident Responder Grant Program

 Ventura County SAFE established Incident Responder Grant Program to provide funds to incident responders in Ventura County

- Provides grant assistance to local first responders for equipment related to motorist incidents
- Provide grant assistance only when the SAFE Fund Balance allows

Round 1 - Current Status

- Agencies must expend funds within two years of receipt of grant funds, with a one-year extension possible upon request
- As of August 2021, Oxnard Police Department, Ventura County Sheriff's Department, and Ventura County Fire Protection District grants have been fulfilled
- City of Ventura Police Department and Fillmore Fire Department grants are planned to be completed by the end of the 2021/2022 Fiscal Year





Incident Responder Grant Program: Example from Round 1

- The City of Ventura Police Department had the single largest application request at \$437,519.62
- Purchase major incident response vehicle to serve City of Ventura and West County through mutual aid


Round 2 Overview

- On July 9, 2021, Commission approved initiation of Round 2 to provide up to \$1,000,000 to agencies that respond to highway incidents within Ventura County
- Grants are for capital expenditures to assist first responders with highway emergency response
- Award range: \$5,000 and \$500,000

Eligible Recipients

 Government agencies, either singularly or in collaboration, that provide roadway incident response on the portions of the California Freeway and Expressway System, and the unincorporated county roads of that county, and on state highway routes that connect segments of these systems, which are located within Ventura County.

Ventura County Network Under SAFE Service Definition



Eligible Expenditures

- Capital assets including computer hardware and software, and equipment used to clear, manage, analyze, and prevent roadway incidents on the SAFE roadways
- Grant funds may not be used for personnel costs or ongoing operational costs
- Capital assets must remain with the grant recipient for the reasonable life cycle of the asset (may not be sold, transferred, or assigned to other agencies or entities)

Application Process

- Four (4) hard copies, including one (1) original with wet signatures and three copies, plus one electronic copy of the application package
- All grant submittals must be delivered to:

- Proposals due September 30, 2021 no later than 4:00 PM
- Proposals received after the application deadline will not be considered

Application Review & Selection Process

CIC

- Scoring Committee comprised of one Ventura County SAFE staff member, two experts in incident response, and one local jurisdiction representative
- Applications scored and ranked according to selection criteria
- Final grant allocations are subject to approval by the SAFE Board

Round 2 Application & Award Schedule

- July 12 16, 2021 Grant Information distributed
- August 3, 2021 at 10:00 AM Informational meeting
- September 30, 2021 Proposals due no later than 4:00 PM
- October 15, 2021 Proposals scored
- November 5, 2021 Ventura County SAFE Board Grant consideration and approval
- Authorization to proceed and grant funds for approved grants will be distributed to grant recipients no later than 30 days after Board approval
