# Ventura County Transportation Commission

## **Proposed Overall Disadvantaged Business Enterprise Goal and Methodology Federal Fiscal Years 2022 – 2024**

### **I. Summary**

On September 7, 2018, The Ventura County Transportation Commission (VCTC) adopted an Overall Disadvantaged Business Enterprise (DBE) goal of 5.0% for federally funded transit project contracts awarded in federal fiscal years (FFYs) 2019 – 2021. The 5.0% DBE goal was to be met entirely through race- and gender-neutral measures (i.e. no contract goals). The DBE goal applies to VCTC and its five sub-recipients: City of Camarillo, City of Ojai, City of Oxnard, City of Thousand Oaks and the Area Agency on Aging. Because the current program expires on September 30, 2021, VCTC has developed a proposed new Overall DBE Goal for the next three-year period that begins October 1, 2021 and ends September 30, 2024. DBE firms received 0.41% of federal funds awarded in FFY 2019 and 0.01% in FFY 2020, well below the adopted 5.0% DBE Goal.

Based on information described in this report, VCTC should consider the following:

- Adopt an Overall DBE Goal of 3.57% for FFYs 2022 – 2024.
- Use narrowly tailored DBE contract goals to help meet the proposed Overall DBE Goal for FFYs 2022 – 2024.
- Set the race- and gender-neutral goal at 1.48% and the race- and gender-conscious goal at 2.09% (total of 3.57%) for FFYs 2022 – 2024.

### **II. Background**

The United States Department of Transportation (USDOT) requires recipients of USDOT funds to establish DBE goals to ensure that small, disadvantaged business enterprises (DBE) can compete fairly for federally funded transportation-related projects. FTA requires the development of an overall triennial DBE goal when FTA funding recipients anticipate awarding more than \$250,000 in FTA funds in prime contracts (excluding transit vehicle purchases) in a federal fiscal year. Because VCTC serves as the designated recipient of federal transit funds for VCTC and the cities of Camarillo, Ojai, Oxnard, Thousand Oaks and the Area Agency on Aging, VCTC is required to adopt a triennial DBE Goal.

USDOT has established a two-step process to assist funding recipients to calculate the DBE goal<sup>1</sup>.

Step 1 of the goal setting process is to determine a measurement of the actual relative availability of DBEs to perform the types of contracts that VCTC and its sub-recipients intend to let. In other words, the analysis is an attempt to determine what percentage of DBEs represent all firms that are ready, willing and able to compete for DOT-assisted contracting. Step 2 of the goal setting calculation process is intended to adjust the base figure calculated in Step 1 to make it as precise as possible. Under the rule, all evidence available should be used to determine whether such an adjustment is necessary. If the evidence does not suggest such an adjustment is necessary, then no adjustment should be made.

### III. DBE Goal Setting Methodology

As noted in section II (Introduction), the DBE goal was calculated using the two-step process described in the “Tips for Goal Setting” guidance provided by USDOT. In Step One a Base Figure was calculated that shows the relative availability of DBEs by dividing the number of DBE firms that are *ready, willing, and able* to compete for project contracts by the number of all firms (DBEs and non-DBEs) *ready, willing and able* to compete for project contracts. The calculation is summarized in the equation below:

$$\text{Step One Base Figure} = \frac{\text{Ready, willing and able DBEs}}{\text{All ready, willing and able businesses (Including DBEs and Non – DBEs)}}$$

In Step Two the Base Figure was analyzed to determine if it requires adjustment upward or downward or left as is. Step One is described in more detail in section IV, and Step Two is described in section V.

### IV. Step One: Calculating the Base (DBE Goal) Figure

Six separate activities were conducted to complete Step One:

- a) Determine the Local Market Area.
- b) Develop a list of federal transit projects scheduled to be awarded in FFYs 2022 – 24.
- c) Assign North American Industry Classification System (NAICS) codes to projects.
- d) Obtain the number of DBE firms *ready, willing and able* to compete for projects contracts in FFYs 2022 – 24.
- e) Obtain the number of all firms (DBEs and non-DBEs) *ready, willing and able* to compete for project contracts in FFYs 2022 – 24.
- f) Calculate the relative availability of DBEs and the Weighted Base Figure which represents the final calculation for Step One.

#### **IV (a) The Local Market Area**

The boundaries of the local market area were determined based on where most of the companies that submitted bids and awarded contracts in past years were located. Bidder and awardee data from FFYs 2011/12 through 2019/20 were used to determine the local market area (see Bidder's List in Attachment 1). Companies were counted only once even if they submitted more than one bid and/or were awarded more than one contract. The local market area was once again determined to be Ventura and Los Angeles Counties because 60% of the bidders and 60% of the firms awarded contracts were located in the two counties. A summary of the location of bidders is provided in Table 1, and the location of firms awarded contracts is provided in Table 2.

**IV (d) DBE Firms Ready, Willing and Able to Compete for Contracts**

DBE firms *ready, willing and able* to perform the anticipated work were identified using the California Unified Certification Program (CUCP) Statewide DBE Directory. NAICS Codes were used to identify DBE firms that indicated their willingness to work in the Local Market Area (Ventura and Los Angeles counties) and able to perform the proposed work. A total of 836 DBE firms were identified and shown in Table 6 by NAICS code. Names and addresses of the 836 DBE firms is provided in Attachment 2 titled “DBE Directory.”

**IV (e) All Firms (Non-DBEs and DBEs) Ready, Willing and Able to Compete for Contracts**

The total number of all firms (including DBEs) *ready, willing and able* to perform the anticipated contracts by NAICS Code was obtained from the U.S. Census Bureau.<sup>3</sup> A total of 15,565 firms located within the Local Market Area were identified as shown in Table 7 by NAICS Code.

#### IV (f) Relative Availability of DBE Firms and Weighted Base Figure

Calculating the Base Figure involves determining the:

1. Weight of each type of work by NAICS Code.
2. Relative availability of DBEs by NAICS Code.
3. Weighted availability Base Figure.

Table 8 shows the weight of each type of work by NAICS code based on the amount of U.S. Department of Transportation (DOT) federal funds assigned to projects. The results show that bus operating assistance comprises 79.85% of total federal funds.

As shown in Table 9, the unweighted relative availability of DBEs is 5.37%. The data also shows that the unweighted relative availability of DBE Trucking firms within the Local Market Area is high at 62.78%; however, less than 1% of total federal funds are expected to go to trucking as shown in Table 8 above.

U.S. DOT recommends that DBE availability be weighted by the amount of federal funds assigned to projects to improve the accuracy of the Base Figure calculation. Table 10 shows that weighting reduces availability of DBEs to 3.57%. This weighted base figure is less than the existing DBE Goal weighted base figure of 5.0% because: bus operations accounts for a greater percentage of the federal funds (79.85%) when compared to the currently adopted DBE program (49%); and there are only two available DBE bus operators.

## **V. Step Two: Adjusting the Base Figure if Needed**

The purpose of Step Two in the DBE goal setting process is to evaluate the Base Figure calculated in Step One to determine if it requires further refinement. The following factors were considered as part of the Step Two evaluation process:

- a) Past participation of DBEs in contract awards including the median participation of DBEs in the previous five years.
- b) Comparing proposed projects to previously awarded contracts, Bidder's List and the DBE Directory to estimate DBE participation in the following three-year period based on race- and gender-neutral measures.
- c) LA Metro Disparity Study conducted in the Local Market Area including marketplace conditions.

- d) Data on employment, self-employment education and training, and union apprenticeship programs in the Local Market Area.

The proposed DBE Goal for FFYs 2022 – 2024 is described in section VI on page 21.

#### **V (a) Past Participation of DBEs**

The percentage of federal transit funds awarded to DBEs in the past five years (FFY 2015/16 – FFY 2019/20) are listed in Table 11. The table shows that past participation of DBEs ranges from 0.01% to 20.0%, with a median of 10.15%. DBE participation was entirely achieved through race- and gender-neutral measures.

The high DBE participation in FFYs 2016, 2017, and 2018 is attributed to the award of contracts to Roadrunner Shuttle, a DBE firm during those years, that operated several bus systems in Ventura County including VCTC Transit and Camarillo Area Transit. Roadrunner Shuttle was purchased by a non-DBE multinational transit operations company named RATP-DEV. Because Roadrunner Shuttle was the only DBE transit operator that bid on transit contracts, it has been a challenge to meet the DBE Goal through race- and gender-neutral measures alone as demonstrated in FFYs 2019 and 2020.

#### **V (b) Comparing Proposed Projects with Projects Awards in Past Years**

Projects proposed for funding in the next three years (Table 3, page 4) were compared to project contracts awarded in recent years of similar work type to estimate DBE participation based on race- and gender-neutral measures. Data for the analysis was obtained from agency contract awards, Bidder's List (Attachment 1), and the DBE Directory (Attachment 2) for similar projects. Table 12 summarizes the results of the analysis which estimates DBE participation at 1.48% based on race- and gender-neutral measures (no contract goals).

### **V (c) LA Metro Disparity Study**

The Los Angeles County Metropolitan Transportation Authority (LA Metro) conducted a disparity study<sup>4</sup> within the Los Angeles County Market Area to help the agency implement the federal DBE Program. The study assessed whether there were any disparities between:

- The percentage of contracting dollars (including subcontract dollars) that minority- and woman-owned businesses received on construction, professional services, and goods and other services contracts that LA Metro awarded between January 1, 2011 and December 31, 2015.
- The percentage of construction, professional services, and goods and other services contracting dollars that minority- and woman-owned businesses might be expected to receive based on their availability to perform specific types and sizes of Metro prime contracts and subcontracts.

The report explains that LA Metro could use the study results to refine its DBE program including setting an overall DBE goal, and, if appropriate, determine which groups would be eligible for any race-or gender-conscious program measures.<sup>5</sup>

The study examined whether there were any disparities between the participation and availability of minority- and woman-owned businesses on contracts awarded by LA Metro during the five-year study period.<sup>6</sup> The Disparity analysis results indicated that:

*“most racial/ethnic and gender groups showed disparities on contracts where race- and gender-conscious measures were not in place during the study period. As a result, Metro should consider using DBE contract goals in the future. The agency will need to ensure that the use of those goals is narrowly tailored and consistent with other relevant legal standards.”<sup>7</sup>*

Several key differences in disparities by contract type and group were identified in the study:

- Black American-owned businesses and Hispanic American-owned businesses exhibited substantial disparities for construction contracts.
- Black American-owned businesses exhibited substantial disparities for professional services contracts.
- All groups of minority- and woman-owned businesses exhibited substantial disparities for

goods and other services contracts.<sup>8</sup>

The study also examined information concerning conditions in the local market area and found that:

*“minorities, women, minority-owned businesses, and woman-owned businesses face substantial barriers nationwide and in Los Angeles County. Existing research, as well as primary research that the study team conducted, indicate that race-based and gender-based disparities exist in terms of acquiring human capital, accruing financial capital, owning businesses, and operating successful businesses. In many cases, there is evidence that those disparities exist even after accounting for various race-neutral and gender-neutral factors such as age, income, education, and familial status. There is also evidence that many disparities are due – at least in part – to race-based and gender-based discrimination.*

*Barriers in the marketplace likely have important effects on the ability of minorities and women to start businesses in relevant Los Angeles County industries – construction; professional services; goods and other services – and operating those businesses successfully. Any difficulties that minorities and women face in starting and operating businesses may reduce their availability for government agency work and may also reduce the degree to which they are able to successfully compete for government contracts.”<sup>9</sup>*

#### **V (d) Data on employment, self-employment education and training, and union apprenticeship programs**

##### **Employment**

According to data from the Southern California Association of Governments presented in Table 13, the number of jobs in Ventura and Los Angeles counties increased by 1.4% and 6.5% respectively from 2007 to 2017. Retail jobs in Ventura County increased by 16.3% whereas construction jobs decreased by 32% and manufacturing jobs by 6.6% during the same 11-year period.

Coronavirus shelter-in-place orders and related business closures has had a significant effect on employment in 2020. Between early March 2020 and mid-September 2020, the weekly unemployment rate in California increased from about 5% to 15.3%.<sup>10</sup> There were 1.73 million fewer workers employed in California in July 2020 compared to July 2019.<sup>11</sup> As of March 2021, the percent of Jobs restored was estimated at 44% in Ventura County and 32% in Los Angeles

County.<sup>12</sup>

Caltrans reports that employment of Black Americans Hispanic Americans, and women in the professional services industry is significantly lower than all industries as a whole. Employment of Black Americans in the construction industry is relatively low compared to other industries in California even within entry-level jobs. The employment of women in the California construction industry as a whole is relatively low, with the majority (94 percent) working in secretarial positions. Employment of Hispanic Americans in the California construction industry is considerably higher than all industries as a whole.<sup>13</sup>

## **VI. Proposed DBE Goal for FFYs 2022 – 2024**

Based on the information in Section V (Step Two Adjustment), VCTC should consider the following:

- Adopt an Overall DBE Goal of 3.57% for FFYs 2022 – 2024 as calculated in Step One in section IV(f) with no further adjustment.

- Use narrowly tailored DBE contract goals to help meet the overall DBE Goal.
- Set the race- and gender-neutral goal at 1.48% and the race- and gender-conscious goal at 2.09% (total of 3.57%) for FFYs 2022 – 2024. The race- and gender-neutral goal of 1.48% was derived by examining the participation of DBEs in past contracts similar to the contracts proposed for FFYs 2022 – 2024. Since all prior DBE Goals were race- and gender-neutral (i.e., no DBE contract goals), all prior contract awards and bidders list information was suitable for use in the analysis. It was assumed that DBE participation in past contracts would be the same for similar contracts proposed in FFYs 2022 – 2024. This calculation is described in section V(b) and represents the maximum feasible portion of the overall goal that can be met through race- and gender-neutral means. The race- and gender-conscious goal of 2.09% was derived by subtracting the race- and gender-neutral goal of 1.48% from the weighted availability of DBEs Base Figure of 3.57% calculated in section IV(f) ( $3.57\% - 1.48\% = 2.09\%$ ).

Federal regulations require that grant recipients meet the maximum feasible portion of the overall DBE Goal through race- and gender-neutral measures.<sup>14</sup> Federal rules also require that contract goals be established to meet any portion of the overall DBE Goal that cannot be met through race- and gender-conscious measures alone. The following provisions apply to the use of contract goals:

- Contract goals may only be used on contracts that have subcontracting possibilities.
- Contract goals are not required on every project.
- The goal for a specific contract may be higher or lower than the percentage of the Overall Goal depending on such factors as the type of work involved, the location of the work, and the availability of DBEs for the work of the particular contract. However, over the period covered by the Overall Goal, grantees must set contract goals so that they will cumulatively result in meeting the portion of the overall goal projected not to be met through the use of race-neutral measures.
- Contract goals must provide for participation by all certified DBEs and must not be subdivided into group-specific goals.
- If during the course of any year in which contract goals are used it is determined that the Overall Goal will be exceeded, the use of contract goals must be reduced or eliminated to the extent necessary to ensure that the use of contract goals does not result in exceeding the Overall Goal. Conversely, if it is determined that the Overall Goal will not be met, then appropriate measures need to be taken to meet the Overall Goal.

- Contractors can meet DBE Goals by either making commitments at the time of bid to include certified subcontractor DBEs at the contract goal amount or by showing they made all reasonable good faith efforts when not being able to meet contract goals.

Federal law requires that DBE programs that include race- and gender-conscious measures meet the **strict scrutiny** standard of constitutional review. The LA Metro 2017 Disparity Study provides a good description of the strict scrutiny standard:<sup>15</sup>

**“Strict scrutiny standard.** An agency must meet both the compelling governmental interest and the narrow tailoring components of the strict scrutiny standard. A program that fails to meet either component is unconstitutional.

**Compelling government interest.** An agency must demonstrate a compelling governmental interest in remedying past identified discrimination in order to use race- or gender-conscious measures. An agency that uses race-or gender-conscious measures as part of a minority- or woman-owned business program has the initial burden of showing evidence of discrimination – including statistical and anecdotal evidence – that supports the use of such measures. Agencies cannot rely on national statistics of discrimination in an industry to draw conclusions about the prevailing market conditions in their own regions. It is not necessary for a government agency itself to have discrimination against minority- or woman-owned businesses for it to act.

Many agencies have used information from disparity studies – specifically, evidence of disparities between the participation and availability of minority- and women-owned businesses – as part of determining whether their contracting practices are affected by race- or gender-based discrimination.

**Narrow tailoring.** In addition to demonstrating a compelling governmental interest, an agency must also demonstrate that its use of race- and gender-conscious measures is narrowly tailored. There are a number of factors that courts consider when determining whether the use of such measures is narrowly tailored including:

- The necessity of such measures and the efficacy of alternative, race- and gender-neutral measures;
- The degree to which the use of such measures is limited to those groups that actually suffer discrimination in the local marketplace;
- The degree to which the use of such measures is flexible and limited in duration, including the availability of waivers and sunset provisions;
- The relationship of any numerical goals to the relevant business marketplace; and
- The impact of such measures on the rights of third parties.”

Because Los Angeles County is part of the Local Market Area for the DBE Goal setting process, it is proposed that the results of the LA Metro Disparity Study be used to meet the *compelling government interest* scrutiny standard for using DBE race- and gender- conscious goals as part of VCTC's FFYs 2022 – 2024 DBE program.

It is further proposed that the *narrow tailoring* component of the scrutiny standard be met through the following measures:

- **Limit contract goals to projects with subcontracting opportunities.** VCTC staff would work with local agency grant recipients (subgrantees) to identify and select the projects that would include contract goals and the goal amounts.
- **Limit contract goals to groups that suffer discrimination in the Local Market Area.** The projects listed in Table 14 are the type of contracts that the LA Metro Disparity study identified as having disparities. As noted in section V(c), the Disparity Study found that all groups of minority- and woman-owned businesses exhibited substantial disparities for *goods and other service* contracts. Projects with NAICS Codes 561720 and 541512 listed in Table 14 are classified as *goods and other service* contracts. The Disparity Study also found that Black American-owned businesses and Hispanic American-owned businesses exhibited substantial disparities for *construction* contracts.
- **Flexible measures and limited duration.** The proposed use of contract goals described in this report is limited to FFYs 2022 – 2024. Contract goals would vary to help meet the DBE Goal and would only apply to projects with subcontracting opportunities.
- **Numerical goals developed based on the relevant business marketplace.** The proposed overall DBE goal of 3.57% is based on the weighted availability of DBE's in the marketplace for the specific projects proposed in FFYs 2022 – 2024. The race-and gender-neutral goal of 1.48% is based on historical DBE participation for the type of projects proposed in FFYs 2022 – 2024, and the race- and gender-conscious goal of 2.09% is the difference between the Overall DBE Goal of 3.57% and the race-and gender-neutral goal of 2.09%.
- **DBE contract goals and the rights of third parties.** If a bidder on a prime contract cannot find sufficient certified DBE participation to meet a contract goal, the bidder can still be awarded the contract by documenting its good faith efforts to find DBE participation.

## VII. Public Notice and Consultation Process

As part of the DBE goal setting process, VCTC is required to consult with persons and groups to obtain information concerning the availability of disadvantaged and non-disadvantaged businesses, the effects of discrimination on opportunities for DBEs, and VCTC efforts to establish a level playing field for the participation of DBEs.

## Proposed VCTC Overall DBE Goal and Methodology FFYs 2022 – 2024

- The consultation process began June 9, 2021 when VCTC sent letters to 35 stakeholder organizations to inform them of the proposed DBE goal for FFYs 2022 – 2024, the various opportunities to comment on the goal and methodology, and the consultation/public notice schedule. The consultation process was scheduled to end on July 15, 2021; however, VCTC and US DOT would continue to accept comments through September 1, 2021. A sample letter to stakeholders is provided in Attachment 3 on page 67, and the stakeholders list is provided in Attachment 4 on page 69.

Following the consultation, VCTC would:

- Post a notice of the proposed overall goals on the VCTC website. Link to the public notice: [Contracts - Ventura County Transportation Commission \(goventura.org\)](https://www.goventura.org/contracts-ventura-county-transportation-commission). **A screenshot of web posting is provided in Attachment 5, page 71.**
- Inform the public that the proposed goal and methodology are available for inspection during normal business hours at VCTC offices for 30 days following the date of the notice.
- Inform the public that VCTC and U.S. DOT will accept comments on the goals for 30 days from the date of the notice.

Stakeholders were invited to a meeting via Zoom videoconference to learn about the goal setting process and to receive comments (a telephone option was also provided to participate in the meeting). The videoconference was held Tuesday, July 13, 2021 at 8:30 a.m. In addition to the videoconference, other opportunities to comment include:

- Additional meetings would be scheduled if requested.
- Mailing address, email address, and telephone number were provided where written comments and questions can be submitted.

### Public Comments and Response to Comments

No comments were received during the July 13, 2021 videoconference as there was zero attendance from the invited stakeholders.

As of July 16, 2021, no comments have been received by mail, email or telephone. This document will be revised to summarize comments received through the end of the comment period including any changes made to the goal and/or the DBE Goal methodology and report based on public comments.

The Ventura County Transportation Commission (VCTC) has established a Disadvantaged Business Enterprise (DBE) program in accordance with regulations of the U.S. Department of Transportation (DOT), 49 CFR Part 26. VCTC has received Federal financial assistance from the Department of Transportation, and as a condition of receiving this assistance, VCTC has signed an assurance that it will comply with 49 CFR Part 26 to ensure that DBEs have an equal opportunity to receive and participate in DOT-assisted contracts.

Every three years, VCTC is required to set an overall DBE goal that it must either meet, or show that it used good faith efforts to meet, annually. VCTC has calculated its DBE goal for Federal Fiscal Years 2022, 2023 and 2024. The proposed goal is 3.57%, consisting of 1.48% race-neutral and 2.09% race-conscious. VCTC used a two-step process to determine this goal as identified in the Federal Transit Administration document "Tips for Goal-Setting in the Disadvantaged Business Enterprise (DBE) Program". The two-step process creates a baseline figure for the relative availability of DBEs and then adjusts the base figure based upon additional evidence, including past experience. The methodology used to calculate the initial baseline figure and any adjustments are explained in the attached report.

As part of the DBE goal-setting process, VCTC is consulting with persons and groups to obtain information concerning the availability of disadvantaged and non-disadvantaged businesses, the effects of discrimination on opportunities for DBEs, and VCTC efforts to establish a level playing field for the participation of DBEs.

Following the consultation, VCTC will post a notice of the proposed overall goals, informing the public that the proposed goal and its rationale are available for inspection during normal business hours at our offices for 30 days following the date of the notice, and informing the public that VCTC and DOT will accept comments on the goals for 30 days from the date of the notice.

Our overall goal submission to DOT will include a summary of information and comments received during this public participation process and our responses.
