



## January 6, 2023, VCTC Report – Planning

#### State Highways to Boulevards (Reconnecting Communities) Pilot Program

Caltrans is developing guidelines for the newly authorized (SHC Section 104.3) Highways to Boulevards Pilot Program. The Program has \$149 million Statewide for grants. 25% for Planning and 75% for Capital. Call for Projects tentatively scheduled for February 2023.

Guideline workshops were held on November 28 and December 19. Next workshop tentatively scheduled for January 31. Project application deadline May 2023. We will provide VCTC with program updates.

#### Climate Change Adaptation for PCH Bike & Pedestrian Infrastructure (7/2022 - 7/2023)

Caltrans District 7 continues to develop study identifying planning level concepts or strategies addressing long term climate change impacts (SLR, storm surge, coastal cliff erosion, etc.) while improving bicycle and pedestrian accessibility in the SR-1 study area. This study will provide Caltrans with climate change adaptation concepts to improve the resilience of the SHS infrastructure in the SR-1 study area and similar coastal locations.

Following completion of the first phase of public engagement, the first in-person public engagement session will be held in February at the Ventura County Fire Department Station 56. The engagement session is scheduled to take place either Wednesday 2/1 or Thursday 2/2 from 4-6pm.

#### Rincon Parkway Feasibility Study for Climate Change Adaptation

District 7 staff is currently applying for funding to complete a feasibility study identifying future adaptation and resilience strategies for sections of SR-1 near Rincon Parkway (VEN-1/21.3 – 28.4). This study is in response to a recent coastal development permit requirement and addresses the long-term resilience needs of this section of SR-1 due to impacts from SLR and storm surge.

Caltrans is working with Ventura County and the California Coastal Commission to develop the SOW and should know if the study will move forward in early February.

### <u>Clean California</u>

Beautification Project in City of Simi Valley – \$3.9 million Finished design (RTL) November 7, 2022 Advertise: Mid-February 2023 Start Construction: Late June 2023 End Construction: November 2023 Background:

The Route 118 Simi Valley Beautification Project enhances interchanges at First Street, Erringer Road, Sycamore Drive, Tapo Canyon Road, Stearns Street, and Yosemite Avenue.

This project places rock cobble, stamped concrete, native and nonnative drought tolerant plants to control erosion providing a pollinator habitat and enhances the visual experience for the local community. Majority of the work is at First Street and Yosemite Avenue, as they are the gateways to the City. Each interchange will have a slightly different plant palette and hardscape.

### Summary of Safety Items on Ventura County Routes

#### Punta Gorda Lot along US-101

Background: Illegal activity of street takeovers/stunts by large groups at this lot which is for Beach Access.

- Director's Order (emergency project) awarded for parking lot modifications installing wheel stops and replacing/updating signage.
- Coastal Permit issued and fees paid.
- Anticipate start work in January 2023.
- Signage efforts with CHP, Ventura County DA and Supervisors office completed, and signs have been ordered by the contractor.
- Working with County and Caltrans Right of Way to determine control/ownership of access road to parking lot.
- Keeping discussions open concerning relinquishment of access road and lot to County.

#### <u>SR-150 w/ Santa Paula</u>

Background: Request to refresh all crosswalks and crosswalk signage along SR-150 between High Street & Virginia Terrace.

- Maintenance has confirmed completion of minimum pavement markings refresh work.
- Other improvements to include this, and other locations on Routes 150, 23 and 33, recommended for placement in a Minor project for design in FY 23/24.

#### Thomas Aquinas College entrance/exit along SR-150

Background: Citizen complaint concerning students not stopping when leaving the college exit and almost causing crashes.

- College has installed the STOP sign at the school exit in the period between October 5 and December 21, 2022.
- Caltrans pursuing Minor project to install warning signs along Route 150 in the approach to the college entrance/exit.
- Installation Order completed by Maintenance in summer/fall 2021 to install no parking signs and striping around college entrance area to mitigate safety matter from extensive parking in the area. Hikers were parking along the route to access a nearby trail and creating safety concerns.

## SR-232 (Vineyard Ave) at Simon Way - Inquiry from Rio School District

Background: Rio School District official requested Caltrans to add protected left turn phasing to existing signal near two schools.

- Engineering review recommended Leading Pedestrian Interval (LPI) instead of protected left turn phasing.
- Caltrans will implement Leading Pedestrian Interval (LPI) phasing for this intersection in January 2023.
- Additional information: The protected left-turn phasing has previously been implemented at the intersection of Forest Park Boulevard, which is the North of the requested intersection of Simon Way. When traveling the northbound of RTE 232 (Vineyard Avenue), this protected left-turn phasing can provide better and easier access to the school district at the intersection of Forest Park Boulevard. In addition, there is greater travel demand for left-turning movement at the intersection of Forest Park Boulevard comparing to the intersection of Simon Way.

### <u>SR-126 (West Ventura Street) at Clay Street in Fillmore-Inquiry concerning shoulder</u> parking & lack of sidewalk for WB 126 in this area

Background: Inquiry concerning shoulder parking in this area, lack of bike lane & lack of sidewalk. Westbound shoulder used for parking and lacks sidewalks between approximately Fillmore Street and Mountain View Street. No bike lane marked in this area, and bicyclists need to enter WB #2 lane to pass parked vehicles.

- Project 07-0W0304 (in Construction) includes new signage before areas where there is parking so that bikes can use the traffic lane.
- A project is required to shift centerline of roadway south, pave EB right shoulder and shift lanes to create space for a bike lane.
- Coordination with D7 Complete Streets team initiated to determine what can be done within programming options for a future project to address this circumstance.
