ITEM 2 INTRODUCTIONS & ANNOUNCEMENTS

Claire Grasty announced that the Commission approved the Transit Integration and Efficiency Study (TIES). Austin Novstrup announced that outreach for Gold Coast Transit District's Short-Range Transit Plan (SRTP) has begun. Lydia Salas announced the City of Camarillo's purchase of a trolley. Ben Gonzales announced that the Simi Valley City Council approved the purchase of two (2) CNG buses and eight (8) paratransit cutaways. Michelle Woomer announced free fares for ECTA passengers through March 2024. Matt Miller announced that the residents of a new Housing Authority project will be purchasing annual transit passes and that VCTC is requesting that operators sign an MOU to accept the

pass and be reimbursed for their services. Heather Miller announced FTIP due dates and the Access for All pilot program soft launch. Tyler Nestved announced that Thousand Oaks Transit was approved for the purchase of two CNG cutaway vehicles (replacing two EV's that had to be returned) and that the City of Thousand Oaks is recruiting a Transit Analyst.

ITEM 8 SB-125 TRANSPORTATION BILL UPDATE

Claire Grasty shared that it is estimated that in the current fiscal year, VCTC apportionments will be \$42.3 million for transit capital and operations and \$5.0 million for zero-emissions transit capital. She said that Ventura County's share is estimated to be another \$42.3 million for transit capital and \$8.5 million for zero-emission transit capital, subject to future budget acts. She added that VCTC staff has been compiling information for countywide projects and needs.

SUBJECT: VCTC FARE ACTIVITY UPDATE

RECOMMENDATION:

BACKGROUND:

The COVID-19 pandemic has had a significant impact on the public transit industry. Fare considerations have been vital in addressing the challenges and concerns for both transit agencies and passengers. Operators continue to face significant budget shortfalls due to decreased ridership and reduced farebox recovery. Short and long-term decisions need to be made about fare adjustments, additional subsidies, or cost-saving measures to ensure financial sustainability in a post-pandemic environment. Flexibility and adaptability related to fare policies and technologies are crucial to address the evolving challenges and ensure public transit remains accessible and equitable for those who need it while ensuring the long-term sustainability of transit agencies.

Several operators have started discussing and/or analyzing their fare systems. Gold Coast Transit District (GCTD) and VCTC are embarking on Short Range Transit Plans (SRTP) that will result in a comprehensive review of fare policies and technologies within Ventura County. VCTC is also engaged in efforts to evaluate technologies countywide that include replacement of fareboxes, increased utilization of the VCbuspass system on fixed-route vehicles, expanding VCbuspass to DAR services in the east county, and adding open-loop payment readers to the Intercity bus fleet through a partnership with SBCAG.

DISCUSSION:

SRTP Fare Evaluation Task

As part of VCTC's SRTP, the project team will be conducting a fare evaluation of all bus operators, except GCTD, who will be moving to increase fares prior to when the fare evaluation will be complete, to assess the equity, efficiency, and effectiveness of fare structures for bus operators within the County. The project team will review current funding source requirements and identify potential strategies to optimize the current fare structures, policies, and technologies. The strategies will address equity concerns (i.e., fare subsidies, reduced fares for low-income individuals, regional fares

or fare capping mechanisms). Components of this fare evaluation that will be included in this task analysis include:

- Policies (i.e. fare adjustment frequency, fare adjustments on consistent schedule countywide, etc.)
- Regional, Premium and Microtransit fares
- Effect of cash collection on operations
- Cost of fare collection
- Analyzing fares and associated equity impacts

This task will result in recommendations for potential fare policy changes and/or adjustments that consider trade-offs between equity goals, fare affordability, revenue generation, and ridership goals. These recommendations will include associated challenges, opportunities, and implementation considerations that will be divided into three time periods:

- 1. Near-Term Opportunities Implement within six (6) months to one (1) year
- 2. <u>Mid-Term Opportunities</u> Implement within the next two (2) years but require additional lead time to implement, including changes to fare technology.
- 3. <u>Long-Term Opportunities</u> Implement with factors that require investments in fare technology, personnel, or capital infrastructure that may take more than three (3) years

The recommendations will include action items, timelines, required resources, and communications strategies required for implementation.

Fare Collection and Technology

Staff have begun to plan for changes in fare collection and related technology. Under deliberation is which technology path to take as several challenges and opportunities have all been presented at the same time.

In 2020, VCTC launched the card or app based VCbuspass with regionally accepted monthly passes and a loaded value option and outfitted all operators with Umo readers. The VCbuspasses also have the ability to be reloaded at CVS, Walgreens, 7-11 and Family Dollar stores countywide (see attached map). Recently, we were notified that at the end of FY25, Genfare would no longer be supporting the Odyssey fareboxes installed on transit vehicles countywide and began to hear about trouble procuring replacement parts for them. Simultaneously, open-loop payment technology has made its way into transit with the help of Cal-ITP and is a priority for VCTC.

As a result of this confluence of factors, staff are deliberating which technology path to take while researching capabilities and costs. Here's some of the factors under consideration:

- Do we replace fareboxes with simple cash only boxes? Or ones with open-loop payment capable?
- If replacing fareboxes with simple cash boxes, do we leverage existing Umo contactless system and swap out current readers with ones that have the open-loop payment capability? What happens to agency GFI paper passes?
- Do we purchase separate readers with another backend system? This is the least desirable option as it would add a third technology system for vehicles with another back-end system.


Based on feedback received from the Committee, VCTC would like to determine the following:

- Do your agencies want to continue to sell your own passes or use solely VCbuspass or another platform like Token Transit or something else?
- Do agencies want to have Cubic/Umo readers on their paratransit vehicles?

SUBJECT: SOUTHERN CALIFORNIA ASSOCIATION OF GOVERNMENTS (SCAG)

REGIONWIDE CALL FOR PROJECTS FOR CONGESTION MANAGEMENT AND AIR QUALITY (CMAQ), SURFACE TRANSPORTATION PROGRAM

(STP), AND CARBON REDUCTION PROGRAM (CRP) FUNDS

RECOMMENDATION:

Request agency information by December 18th regarding cost increases for previously selected projects from competitive project selections, or (on a very limited basis) new projects they wish to nominate, for consideration for the upcoming SCAG call for projects for which applications will be due from SCAG to VCTC by March 29 2024, and for consideration of FY 24/25 Transportation Development Act (TDA) Article 3 funds.

BACKGROUND:

In December 2022, VCTC completed its project selection process for CMAQ and CRP projects using funds made available by the federal Infrastructure Investment and Jobs Act (IIJA). The project selection process also programmed the Transportation Development Act (TDA) Article 3 Bicycle and Pedestrian funds for Fiscal Year (FY) 22/23 and FY 23/24.

As has been previously discussed, in 2021 the Federal Highway Administration (FHWA) notified Caltrans that multi-county MPOs such as SCAG should play a more active role in the selection of projects to be funded with the Surface Transportation Program (STP) and Congestion Mitigation and Air Quality (CMAQ) program that are destined to Ventura County. Later, FHWA notified Caltrans and the Southern California Association of Governments (SCAG) that SCAG had until July 2023 to adopt a new process for selection of CMAQ and Surface Transportation Program (STP) projects whereby projects are prioritized on a regional basis. Since VCTC was established in 1989, it had received a specific apportionment of these funds and submitted the recommended project list to SCAG for review and approval as specified in the state law governing county transportation commissions.

It was understood that programming actions for STP and CMAQ that occur prior to the June 2023 deadline would be grandfathered in, and the funding will be secured for those projects. As a result, the county transportation commissions were able to commit the estimated funding through fiscal year 2025/26. While the new Carbon Reduction Program (CRP) established under the IIJA was not part of the prior federal direction that was provided, given that the federal authorizing

language was very similar to STP and CMAQ, it was anticipated that in the future CRP might be incorporated into the new process.

On February 13th, FHWA staff informed SCAG that the new regionwide prioritizing process must also apply to CRP, but that in this case there would be no transition period, and so that new CRP projects cannot be programmed in the Federal Transportation Improvement Program (FTIP) until SCAG has adopted its new regional prioritization process and then completed the process for the selection of CRP projects. The only exception to this requirement for CRP was to allow SCAG to move forward with programming ready-to-go projects identified by the County Transportation Commissions to receive funds apportioned to CRP during the first year of IIJA, FY 21/22, to ensure that these funds will be obligated before they lapse in September, 2025. VCTC had identified five (5) projects to receive CRP funds apportioned through FY 25/26, but as a result of the FHWA directive SCAG could only approve the FY 21/22 CRP funds. As a result, VCTC in working with TTAC recommended that \$4,667,000 that VCTC had intended to commit to the Central Avenue Bike Lanes project in Camarillo instead be identified as a priority for a future request to SCAG for CRP funds. However, at last month's meeting TTAC instead approved the staff recommendation to include the \$4,667,000 in VCTC State Transportation Improvement Program (STIP) nomination to the California Transportation Commission, to receive funds from the Ventura County STIP share.

SCAG is now developing selecting guidelines for the required regionwide call for projects, and shared preliminary drafts with county transportation commission staff for review. Subsequent to the commissions' CMAQ and STP project selection, Caltrans completed updated CMAQ and STP apportionments based on IIJA authorized amounts, resulting in an incremental increase in these funds which are subject to the new SCAG process, in addition to the authorized CRP funds from FY 23/24 forward.

Under the draft process, the county commissions will prioritize and submit applications to SCAG, selecting projects for consideration based on their own process for the county, subject to various requirements for encouraging broad participation. The deadline for county commission submittal of applications is March 29, 2024. SCAG has also provided to VCTC a preliminary draft application.

DISCUSSION:

The SCAG CRP Guidelines call for 65% of the CRP funds to be programmed through a call for projects, with the remaining 35% to be programmed to regional initiatives, to identify, evaluate, and awarded funding to projects that achieve regional transportation goals and further the objectives of Connect SoCal. SCAG has developed the following estimates for funds available in the regionwide call for projects, including the incremental increase in CMAQ and STP, and 65% of the CRP funding for FY 22/23 – 25/26:

CMAQ \$ 57 million STP \$130 million CRP \$ 88 million

The draft guidelines for STP and CMAQ identify advisory county funding targets percentages based on various planning criteria, and the Ventura County targets are 4.3% for STP, or \$5.6 million, and \$3.3% for CMAQ, or \$1.9 million. SCAG does not believe that FHWA will allow publication of advisory targets for CRP. For illustrative purposes, since the IIJA authorization of CRP has the same language as Surface Transportation Block Grant, which California distributes to regions as STP, if CRP were to have the same 4.3% target as STP, then VCTC's target would be \$3.8 million.

Staff will share the SCAG guidelines with the committees when they become publicly available. We believe that the requirements for outreach in identifying candidate projects will have been met, due to various VCTC's previous efforts, including: (1) the public outreach conducted in

support of VCTC planning efforts including 101 Communities Connected, the Freight Corridors Study, and the Comprehensive Transportation Plan Update; (2) the recent CMAQ/STP/TDA Article 3 call for projects; and (3) the ongoing work with the transit operators to identify projects for use of state budget funds made available to transit through SB 125.

Given the relatively small amount of money likely to come to Ventura County, there will be few if any new projects that VCTC can consider for submittal to SCAG, and the priority for the available funds is likely to be assisting previously committed projects which are short of funds due to unanticipated cost increases. Staff recommends that local agencies be asked to provide to VCTC staff by December 18th the amount of funds required for such projects. Subsequent to receiving feedback from TRANSCOM and TTAC, VCTC anticipates sending a notice to public works directors on November 20th, requesting information on projects requiring additional funds.

Rather than developing project numerical scores and a ranked list, the SCAG draft guidelines provide for county commissions to submit a project list with each project designated as "Highly Recommended," "Recommended," or "Contingency." Commissions are required to develop a written procedure for selecting projects to submit to SCAG, and to assign priority, and this written procedure must receive prior SCAG staff approval. Accordingly, VCTC staff intends to prepare the project prioritization procedure for Committee approval in January. The SCAG draft guidelines provide that the county commission's prioritization will account for 50% of a project's score for CMAQ and STP, and 20% for CRP.

At the February committee meetings, staff plans to recommend the SCAG project submittal list and the assignment of priority categories. Staff will then work with the project sponsors to complete the SCAG project applications for the selected projects, to be submitted by VCTC to SCAG by the March 29th deadline. In addition, as part of this project prioritization process VCTC will also identify projects to use the approximately \$750,000 of TDA Article 3 to come available in FY 24/25, not including the maintenance set aside.

Although staff plans to bring formal prioritization criteria to the committees in February, given the relatively small amount of available funds, we expect the projects to generally be selected and prioritized as follows:

- Project readiness;
- For previously committed competitively selected projects, the ranking score that it received when it was originally selected;
- For STP, continuing VCTC's policy of giving priority to the US 101 project.
- Should a new project be considered for CMAQ, CRP, or TDA Article 3, it will likely have
 less readiness than a previously committed project, but should funds be available it could
 be further ranked using VCTC's previously approved criteria for CMAQ, CRP and Article
 3:
- Assignment of projects to CMAQ or CRP fund types based on likely competitiveness given SCAG's different criteria for the two programs.
