ITEM 6 SHORT RANGE TRANSIT PLAN/PARATRANSIT INTEGRATION ANALYSIS UPDATE

The timing of when agencies whose fares are lower than \$1.50 should increase fares and when agencies that already have fares at \$1.50 or above should move to increase fares to \$2.00 and where agencies with fares of \$2.00 fit in. The timing has not been specified and generally operators should do what works best for their agencies.

Open loop payments and fare capping. The regional open-loop system will have fare capping and will allow for day, weekly and monthly passes.

SUBJECT: SB 125 YEARS 2, 3 AND 4 FUNDING DISTRIBUTION AND UPDATE ON CAP-AND-TRADE FUTURE

RECOMMENDATION:

• Approve the updated SB 125 fund distribution for Years 2, 3 and 4.

BACKGROUND

The SB 125 funds are comprised of Transit and Intercity Rail Capital Program (TIRCP) and Zero-Emission Transit Capital Program (ZETCP), which includes funds from the Public Transit Account (PTA) and the Greenhouse Gas Reduction Fund (GGRF). The TIRCP funds were initially planned to be split over two years, Years 1 and 2. The ZETCP funds were and are still planned to be spread over Years 1, 2, 3 and 4, with the same amount of funding in Years 2 through 4.

However, due to State budget shortfalls, the Year 2 TIRCP funds are planned to be split over two years. Furthermore, the Governor has recommended changes to the Cap-and-Trade program that threatens TIRCP and ZETCP funds beyond Year 4.

The Cap-and-Trade program is set to end in FY 2029. As part of his May Revise, the Governor recommended significant allocations to High Speed Rail and Calfire (\$1B and \$1.5B respectively). While no cuts to existing cap-and-trade programs, revenues are generally between \$2-4B, which does not allow funding for existing commitments including Years 3 and 4 of TIRCP and ZETCP funds. A total of what is at stake is \$26.9M.

Other programs such as the Low Carbon Transit Operations Program (LCTOP), Affordable Housing and Sustainable Communities (AHSC) program and the TIRCP discretionary program are also at risk. The LCTOP program in particular has funded many critical programs in Ventura County, including the Youth Ride Free, College Ride and Free Fare Days programs.

DISCUSSION

When the SB 125 funds were allocated between the two TIRCP years and four ZETCP years, they we allocated based on when funding was needed for projects the funds were requested for. After the first year of funds were delayed and future years of funding did not seem locked in, funds were reallocated between the years to balance the risk across the transit operators.

Based on the split of TIRCP Year 2 funds between Years 2 and 3 and due to the risk of losing TIRCP Year 3 funds, as well as ZETCP Years 3 and 4 funds, the funds are once again being reallocated. Funds were primarily split between TIRCP Years 2 and 3 but there were changes made to ZETCP funds to help balance the risk between the transit operators. With the exception of VCTC led projects, funds are split in half for the operators. VCTC prioritized operations and vehicle replacements of VCTC led projects while projects that could be deferred or were already slated for funding in later years, remained to ensure the transit operators received funds sooner.

VCTC will need to know from the transit operators how they want the funds split between the project line items by June 20.

SUBJECT: VCTC PROJECT NOMINATION PACKAGE FOR THE SOUTHERN CALIFORNIA ASSOCIATION OF GOVERNMENTS (SCAG) REGIONWIDE CALL FOR PROJECT NOMINATIONS FOR SURFACE TRANSPORTATION BLOCK GRANT (STBG) AND CONGESTION MITIGATION AND AIR QUALITY (CMAQ) FUNDING

RECOMMENDATION:

• Recommend the Commission approve the VCTC Nomination Package and submit to SCAG

BACKGROUND:

The Surface Transportation Block Grant (STBG) Program and Congestion Mitigation and Air Quality (CMAQ) Improvement Program are Federal Highway Administration (FHWA) programs that provide funding for transportation. STBG provides funding to best address state and local surface transportation needs, and CMAQ provides funding for projects or programs that improve air quality, relieve congestion, and generate an emissions reduction in, or offer a benefit to, a nonattainment or maintenance area.

In past years VCTC was provided, per state law, with a county apportionment for these funds and would make recommendation to SCAG the projects to be programmed in the Federal Transportation Improvement Program (FTIP). As of July 1, 2023, SCAG is now responsible for conducting a regionwide request-for-project nominations process for selection of STBG and CMAQ-funded projects.

On March 31st SCAG released guidelines for the call-for-project nominations for STBG and CMAQ funds. As per these guidelines, project sponsors submitted applications by the deadline of May 16th. Although in 2024 SCAG distributed an incremental increase in funds, this call-for-project nominations represents the first time of utilizing this new process for prioritization and the full amount of funds for one funding cycle.

VCTC is now responsible for the coordination and submission to SCAG of a Ventura County Project Prioritization Framework and a Project Nomination Package. SCAG will review the Project Nomination Packages submitted by VCTC and the other County Transportation Commissions (CTC's) against the program criteria and develop a list of prioritized projects for approval by the SCAG Regional Council.

Projects approved by SCAG for STBG and CMAQ funding will then be programmed in the 2027 FTIP, and a contingency list will be maintained by SCAG for any cost savings or future funding opportunities. Staff are seeking committee and VCTC approval of the Project Nomination Package (Attachment A) and direct staff to submit the Project Nomination Package and associated documentation to SCAG for evaluation and project selection.

This item supports the 2023 VCTC Strategic Plan Tier 2 Top Priorities including integrating the Comprehensive Transportation Plan (CTP), encouraging local partners to plan and prioritize building new bike lanes (and seeking funding for this purpose), and coordinating efforts to prioritize and submit grant applications for goods movement.

DISCUSSION:

The CMAQ and STBG Program Guidelines established the structure for project selection and allocation of federal funds within the SCAG region. The guidelines were developed by SCAG in consultation with CTCs in the region. There were three workshops for Ventura County eligible applicants on the SCAG guidelines and new application process; two were held virtually by SCAG and one was hosted in person by VCTC at the Camarillo library with excellent turnout.

This nomination package will primarily make funding available from apportionments for federal fiscal year (FFY) 2026/27 and FFY 2027/28. STBG and CMAQ funding are subject to the Timely Use of Funds with obligation and/or Federal Transit Authority (FTA) Transfer deadlines for these apportionment years being September 30, 2029, and September 30, 2030, respectively. The current federal surface transportation authorization, the Infrastructure Investment and Jobs Act, is in effect through September 2026. Therefore, funding availability for the call for project nominations is subject to a subsequent congressional reauthorization or continuing resolution.

Table 1, Project Selection Milestones, outlines the tentative dates for key milestones for the call-for-project nominations process and is updated as necessary with communication to this committee.

The funding availability for this call for project nominations per the SCAG guidelines, is set by program target percentages. The Ventura County region STBG target percentage is 4.3%, or roughly \$27M, and the CMAQ target percentage is 3.3% or roughly \$20M.

The VCTC Project Nomination Package presented in Attachment A identifies the prioritized list of projects scored through the rubrics of the VCTC Project Prioritization Framework approved by VCTC April 4, 2025, which outlined how projects would be prioritized for funding as part of the final SCAG selection. This framework was posted to the VCTC website and was presented at the March 2025 workshop as well. VCTC staff worked closely with local agencies throughout Ventura County to navigate the new project application software, ensure air quality improvement calculations and cost benefit were sufficient for CMAQ applications, and answer any questions that came up throughout the process.

All told there were thirty (30) project applications from twelve (12) agencies from throughout Ventura County. Many of the projects requested CMAQ, however STBG had higher requested dollar amount overall. The smallest project request was \$443,000 while the largest single request was just over \$3 million. The majority of applications had prior funding from either STBG and/or CMAQ, or from other sources such as Active Transportation Program or other federal programs and had incurred cost increases in the past five years requiring additional funding to complete. All projects listed "highly recommended" will be ready to obligate the federal funding in the first year of the program (FFY 2026/27).

At the top of the recommendation table in Attachment A are two projects of note. The \$4 million for the Oxnard Harbor District was previously approved for immediate use by SCAG at the recommendation of VCTC for the Shoreside Power Project cost increase. The project second is the US 101 High Occupancy Vehicle (HOV) lanes and it will not need additional funds withing the time horizon of the available funds in this call for projects, but the project must be shown on the recommendation list to document that is has been selected though the new SCAG managed project selection process.

Staff recommend the committee approve for recommendation to the Commission the Project Nomination Package as shown in Attachment A.

SUBJECT: FY 2025/26 STATE OF GOOD REPAIR PROGRAM – PROJECT SUBMITTALS

RECOMMENDATION:

• Information and Discussion

BACKGROUND:

The State of Good Repair (SGR) Program is a noncompetitive, formula-based program included under The Road Repair and Accountability Act of 2017, Senate Bill (SB) 1. Funds are deposited into the State Transit Assistance (STA) account and then distributed to regional transportation agencies using the STA Program formula, with half of the SGR funds being allocated according to population (PUC 99313) and half of the SGR funds allocated according to transit operator revenues (PUC 99314). The goal of the SGR Program is to provide funding for capital assistance in rehabilitating, modernizing, and maintaining the state's existing local transit systems in a state of good repair.

A preliminary estimate of funding allocations for the FY 2025/26 SGR program was released by the State Controller's Office on January 30, 2025. The following table provides the fund estimates for Transit Operators in Ventura County:

A final estimate of available allocations is anticipated to be released in August 2025. In the past, the August estimate has not varied significantly from the January estimate, therefore VCTC is providing the January estimate as the funding basis for the planning of potential projects. Transit operators will be notified of the August estimate should it vary from the January estimate as soon as those amounts are available.

INFORMATION AND DISCUSSION

The SGR Program is a transit capital program that maintains the public transit system in a state of good repair. The program encourages eligible recipients to promote "fix-it-first" transit capital projects that reduce greenhouse gases and help achieve the state's environmental goals.

Each fiscal year, regional entities (RTPAs), working in conjunction with their local transit operators, are required to compile and forward to Caltrans a list of projects proposed to be funded with the year's apportionment of SGR funds. VCTC, as the designated regional entity, is required to review the proposed projects to ensure they meet the SGR eligibility criteria and to then submit a VCTC Board Resolution to Caltrans that includes all Ventura County projects. Projects' eligibility criteria include:

- whether the project has been approved by the Transit Operator's board and/or the project is included in an adopted document such as the short-range transit plan;
- whether the project is appropriate for the overall transit plan designed for the region; and
- whether the total estimated amount of SGR funds to be made available to the transit operator agrees with the August estimate letter issued by the California State Controller's Office.

The SGR Resolution listing all of Ventura County's FY 2025/26 SGR projects is scheduled for approval at the September Commission meeting. In order for adequate review of projects prior to Commission approval, VCTC is requesting **Transit Operators submit their project lists to VCTC by Friday, July 18, 2025**. Project submittals must include:

- Project scope and description (include asset type);
- Project overall funding plan;
- Project schedule; and
- Estimated useful life of the project (asset).

Agencies must submit a signed cover letter on the agency's letterhead to VCTC indicating that the project has been approved by the Transit Operator's board and/or that the project is included in an adopted document such as the short-range transit plan (include a link to the publication). According to SGR guidelines, previously submitted projects are eligible to receive additional SGR funds with a four-year allowable accrual of funds. Recipients must begin expending funds by the fourth year and fully expend the funds within the following four years.

Following Commission approval, VCTC staff will submit the SGR Resolution to Caltrans. Caltrans will provide the State Controller's Office with a list of eligible recipients and funding amounts. VCTC will receive and sub-allocate the funds from the State Controller's Office to the Transit Operators on a quarterly basis beginning in November 2025. **Transit Operators are required to enter their approved projects into the CalSMART database by September 1** and thereafter track project expenditures and submit project progress/expenditure reports annually.
