# Transportation Emergency Preparedness Plan

#### Transportation Emergency Plan Overview (TEPP) Overview

- Developed through a partnership between Santa Barbara County Association of Governments (SBCAG) and VCTC
- Addresses transportation challenges related to disasters that affect Ventura and Santa Barbara Counties



TEPP Implementations

Staff the Transportation seat at the EOC to coordinate resources

- Inventory of transportation assets, resources, and contacts to use in emergency
- Participation in TransMAC by multiple VC and SBC operators
  - Attended training led by TransMAC
- Formal participant in County's Regional Radio System (RRS) – now implementing
- GCTD has implemented contingency fleet
- Grant to prepare a Multimodal Transportation Network Climate Vulnerability Assessment and Action Plan



### New Radios for Bus Operators

- Replacing aging communication systems with modern, interoperable radios
- Enhance real -time communication between operators, dispatch, and emergency services
- Supports regional coordination, particularly during detours, emergencies, or special events
- Aligned with countywide and statewide efforts to modernize public safety communications

### Additional Temporary Peak Period Intercity Rail Service

- Roundtrip funded by the Santa Barbara Association of Governments (SBCAG) and VCTC
- New northbound morning train paired with an existing afternoon southbound train
- Temporarily utilizes LOSSAN's available "slot" on UPRR railroad Right -of-Way (ROW)
- LOSSAN to subcontract with Metrolink for operations

### Additional Temporary Peak Period Intercity Rail ServiceAgreement Timeline

- January -February 2025 Start -up Agreement Approved
- March -April 2025 Service Plan Finalized by Metrolink and LOSSAN
- May-June 2025
  - Draft Operating Agreement presented by Metrolink
  - LOSSAN legal review: Metrolink will serve as subcontractor to LOSSAN
- June July 2025 Revised Agreements
  - Funding Agreement VCTC/SBCAG & LOSSAN
  - Subcontractor Operating Agreement LOSSSAN & Metrolink
  - SBCAG/VCTC Issued Notice to Proceed with Crew Training (minimum of 60 days)
- August -September 2025
  - Finalize Operating and Funding Agreements
  - Union Pacific Review: Separate Agreement will be required (Crew training pending UPRR Agreement)



### Additional Temporary Peak Period Intercity Rail Service Next Steps

- August -September 2025 Finalize Operating and Funding Agreements
- September -October 2025 –
   Approve Operating and Funding Agreements
- **Pending** Union Pacific Agreement
  - Training & Service Launch ~12 weeks out
- Goal service implementation in early 2026











### Leesdale Siding Extension and Upgrade

#### **Project Overview**

- Construct new 3.4 -mile long siding.
- Allows for greater operational flexibility for Pacific Surfliner and Metrolink service.
- Design estimated to be complete in Spring of 2026
- Construction estimated to begin in Fall 2026

Camarillo Station Americans with Disabilities Act (ADA) Improvement Project







## Camarillo Station ADA Improvement Project

#### **Project Overview**

- In 2021, VCTC entered into a settlement agreement with U.S. Department of Justice (DOJ)
- Improvements include:
  - Increasing accessibility on routes to/from the public right -of-way, public transit, accessible parking, and the passenger loading zone due to gaps
  - Remedying abrupt elevation changes and improper slopes
  - Adding detectable warnings at pedestrian/vehicular transition areas, and curb ramps, and
  - Improving signage to be ADA -compliant



## Camarillo Station ADA Improvement Project

#### **Project Overview**

- 100% design
- Staff waiting on Union Pacific Railroad (UPRR) for a Right -of-Entry (ROE) permit – leading to delay
- ROE permit is required to receive approval from California Transportation Commission (CTC) for funding allocation
- Staff anticipating release of an Invitation for Bids (IFB) for construction in October or December 2025







#### Camarillo Train Station Undercrossing Project

- Construct a new Americans with Disabilities Act (ADA) compliant pedestrian undercrossing, better linking the two platforms
- Existing pedestrian overpass is not ADA compliant
- The Project is intended to create a more direct, convenient, and accessible path to access the platforms on either side of the tracks.
- Design is anticipated to be completed in 2026 with construction estimated to begin in 2027 -2028


Metrolink Simi Valley Double Track Project



## Metrolink Simi Valley Double Track Project

- Part of Metrolink's SCORE Capital Plan
- Enable more frequent train service
- Improve service reliability and on -time performance
- New platform access with an underpass
- Enhanced safety at improved at -grade crossings will facilitate Quiet Zone ready corridors
- Completed acquisition of last parcels
- Negotiating with UP on fiber relocation is last remaining item
