

**AMENDMENT NO. 1
TO
INTERAGENCY AGREEMENT BETWEEN
VENTURA COUNTY TRANSPORTATION COMMISSION
AND
CITY OF THOUSAND OAKS**

This Amendment No. 1 ("First Amendment") is made as of this ____ day of November, 2025 ("Effective Date") by and between the VENTURA COUNTY TRANSPORTATION COMMISSION ("VCTC"), and CITY OF THOUSAND OAKS. ("CITY"). CITY and VCTC are sometimes referred to herein together as the "Parties" and singularly as a "Party".

RECITALS

WHEREAS, VCTC and Contractor entered into an agreement on February 23, 2025 pursuant to which VCTC agreed to allocate Grant Funds and CITY agreed to implement the Project ("Project"); and

WHEREAS, the Parties desire to amend the Agreement to revise the Scope of Services and Grant Funds Amount.

NOW THEREFORE, VCTC and CITY agree as follows:

1. Scope of Services (Section 2a to the Agreement) is amended to replace the existing language with the following language:
 - a. Grant Administration: As the original fund recipient, VCTC shall be responsible for distributing the Grants Funds to CITY to be used for the Project. VCTC has agreed to distribute a not-to-exceed amount of \$8,700,000.
2. Scope of Services (Section 2b to the Agreement) is amended to replace the existing language with the following language:
 - a. Project Implementation: CITY will implement Electric Vehicle Charging infrastructure, Electric Vehicle Charging consulting support, and vehicle replacements.
3. Scope of Work (Exhibit A to the Agreement) is amended to repeal the existing Exhibit A and replace it with Exhibit A- Revised, attached hereto and incorporated herein.

Except to the extent amended herein, all other provisions of the Agreement remain unchanged and in full force and effect.

This First Amendment may be executed in counterparts and/or by facsimile or other electronic means, and when each Party has signed and delivered at least one such counterpart, each counterpart shall be deemed an original, and, when taken together with other signed counterpart, shall constitute one original, which shall be binding upon and effective as to all Parties.

Exhibit A – Revised Scope of Work

Project	Program	Description
EV Charging Infrastructure	ZETCP	This project will fund the design and construction costs of Electric Vehicle (EV) Charging Infrastructure project including the installation of a battery backup microgrid system, EV pedestal chargers, EV pantograph chargers, and all incidental work and electrical upgrades required for a fully working and operational EV charging system.
EV Support	ZETCP	This project will fund the support systems for a Battery Electric Bus (BEB) public transit fleet. The project will include the identification and procurement of tools, equipment, and software that may include but is not limited to; mobile battery EV chargers, charge management systems, BES-specific safety equipment, and BES-specific tools, and all incidental equipment necessary for BEB maintenance and testing.
Farebox Replacement	TIRCP	This project will fund the procurement of farebox infrastructure and installation for Thousand Oaks Transit vehicles. The project includes both the procurement and installation of new farebox equipment to replace existing equipment on existing TOT vehicles and the procurement of new farebox equipment on new TOT vehicle purchases.
