

**AMENDMENT NO. 1
TO
MEMORANDUM OF UNDERSTANDING BETWEEN
VENTURA COUNTY TRANSPORTATION COMMISSION
AND
CITY OF MOORPARK**

This Amendment No. 1 (“First Amendment”) is made as of this ___ day of _____, 2026 (“Effective Date”) by and between the VENTURA COUNTY TRANSPORTATION COMMISSION (“VCTC”), and CITY OF MOORPARK. (“CITY”), (sometimes referred together as the “Parties” and singularly as a “Party”).

RECITALS

WHEREAS, VCTC and CITY entered into an agreement on August 14, 2025 pursuant to which City agreed to improve bus stops (“Agreement”); and

WHEREAS, the Parties desire to amend the Agreement to provide additional funding and extend the term.

NOW THEREFORE, VCTC and City agree as follows:

1. **Section 1 of the Agreement shall be amended as follows:**

ALLOCATION OF FUNDING: VCTC hereby agrees to increase the total not-to-exceed amount set forth in Section 1 of the Agreement by \$115,700 to a total not-to-exceed amount of \$340,700.

2. **Section 2 of the Agreement shall be amended as follows:**

SCOPE OF SERVICES/PROJECT: CITY shall design, purchase and install materials, amenities and any necessary hardscape improvements for a custom bus shelter on the north side of High Street and for the replacement of trash receptacles for bus stops and bus shelters, as well as installation of new trash receptacles at all bus stops and bus shelters in the City (“Bus Stop Amenities” or “Project”) and related costs required to accommodate the amenity installations and maintain accessibility of pathways and landings. CITY shall utilize professional services to assist in implementation of the Project.

3. **Section 3 of the Agreement shall be amended as follows:**

DURATION OF MOU AND AUTHORIZATION TO PROCEED: The term of the Agreement set forth in Section 3 shall be extended by six (6) months through December 31, 2026.

Except to the extent amended herein, all other provisions of the Agreement remain in full force and effect.

This First Amendment may be executed in counterparts and/or by facsimile or other electronic means, and when each Party has signed and delivered at least one such counterpart, each counterpart shall be deemed an original, and, when taken together with other signed counterpart, shall constitute one original, which shall be binding upon and effective as to all Parties.
